## 3. Call for proposals, job opportunities

#### Full-time Junior Research Associate - Vrije Universiteit Brussel

The Department of Sociology – Research group Interface Demography, Vrije Universiteit Brussel, is looking for a full-time junior research associate with interest in quantitative social science research to work on a challenging research project: The social distribution of cancer in Belgium. Socioeconomic inequalities in cancer mortality around the turn of the century Aim of the project

The post holder is expected to conduct quantitative research on SE inequalities in cancer mortality, under the supervision with the project coordinators. The aim of the project is to map social inequalities in cancer mortality (divided into specific causes such as breast and lung cancer) in detail via statistical, demographic and epidemiologic analyses using a census-linked follow-up study. This project aims to unravel SES inequalities in cancer mortality in Belgium and to gain insight in trends in those patterns between the beginning of the 1990s and the end of the 2000s. The findings should result in the submission of a doctoral dissertation in the social sciences and in publications in scientific journals.

# Three study scholarships in Global Nutrition and Health – Metropolitan University College Copenhagen

To prepare health professionals to address our greatest public health challenges At the Metropolitan University College (Metropol) in Copenhagen, Denmark, The WHO Collaborating Centre for Global Nutrition and Health is offering 3 candidates the opportunity to study for a Bachelor's degree in global nutrition and health. Three scholarships which cover full-time tuition fees for 3½ years commencing September 2013 are being offered. Metropol's bachelor's degree in global nutrition and health is a unique education which focuses on contemporary global challenges in nutritional health and sustainability, and includes the following strategies: health promotion; disease prevention, lifestyle management, public health nutrition and food policy. These strategies address: the global burden of disease and health risks, the double burden of disease, the Millennium Development Goals, non-communicable diseases (NCDs), and nutrition and physical activity.

For the bachelor's degree:

- All tuition is in English and teaching is carried out by top international academics
- Students are required to complete two separate internships (20 weeks in total)
- Excellent international academic standards are maintained
- A global perspective and cross-cultural interaction is central to the education
- All tuition fees are covered by the Global Nutrition and Health scholarship.

To be eligible for the scholarship, prospective candidates should:

# 4. Interesting News

#### EU plans tougher tobacco health warnings

This is planned in the long-awaited and revised EU Tobacco Directive, released on 19 December. "Tobacco kills half of its users and is highly addictive," said EU Health Commissioner Tonio Borg, presenting the proposals. Almost 700 000 Europeans die from tobacco-related illnesses each year − equal to the population of Frankfurt or Palermo − with associated health costs running at more than €25bn.The proposed new rules on labelling, ingredients and smokeless products, fall short of demands by health campaigners for a total ban on company branding and logos on packets, along the lines of measures enforced in Australia. But the legislation would allow member states the option of plain, non-branded packaging "in duly justified cases".

The draft directive would require 75% of the packet to be covered - front and back - with the warnings. But company branding would not be banned. It would also ban strong flavours such as menthol or vanilla, which can mask the bitter tobacco taste.

"Tobacco products should look and taste like tobacco products," Borg said. "This proposal ensures that attractive packaging and flavourings are not used as a marketing strategy." The revisions to the EU's 2001 tobacco directive could become law in 2014.

#### **EPPOSI (European Platform for Patient Organisations, Science and Industry)**

Epposi's White Paper "Building a workable framework for the holistic management of chronic conditions in Europe" has been published. This report summarises the key policy recommendations for the practical implementation of integrated chronic care models in Europe.

Following-up the publication of this highly valuable policy document, Epposi organized a multistakeholder *Chronic Conditions Management Conference* "An Optimal European Chronic Care Model: Towards Implementation and Benchmarking" taking place on December 5<sup>th</sup> at Marivaux Hotel in Brussels which directly built on the White Paper outcomes.

For this conference representatives of patient organisations, academia and industry with expertise in the field of chronic conditions management and integrated care have been invited in order to provide contribution to the further development and implementation of Epposi Chronic Conditions Management (CCM) programme. Dr Iveta Rajnicova-Nagyova, president of the EUPHA section on Chronic Diseases, represented EUPHA at this event; where she also moderated a 'Multi-stakeholder Panel Discussion to reflect on the Implementation Strategy of the Epposi CCM model'.

The research outcomes of the conference and the Epposi AIP-CCM Programme directly feeds into the European Commission, DG SANCO, EIP-AHA initiative and development of the Action Plan of B3 Integrated Care group.

#### Europa Media Non-profit Ltd – news update 3: Build the consortium

In order to have a good project and good collaboration, partners need to complement one another and they shall share an interest in the common problem they will be tackling in their research.

The minimum number of partners and any requirements related to their geographical location, legal form and expertise are determined in the call. Following the thoughts of the previous blog post, the partnership is defined mostly by the expertise you need to have in the consortium to achieve the objectives and be able to have a considerable impact.

An ideal consortium in an ideal world

- is well balanced in terms of geographical coverage (north-south-east-west, New and Old Member States);
- involves partners from different sectors (industry, academia, public and private bodies, networks and Non Governmental Organisations);
- carries out all tasks internally and subcontracting is used only for minor tasks and because absolutely necessary;
- has the best available experts for all tasks in Europe or the world on board;
- has relevant references in terms of international activities/research and EU projects in the relevant fields;
- is led by an experienced coordinator;
- is fully committed to the project and all partners have a clear plan on how the achievements will be used after the end of the project.

Having an excellent partnership should be always your scope, but after 10 years of building consortia, I am not sure I have ever achieved the perfection. But trying was worth it.

You cannot always work with partners you know well, sometimes you have to take a risk and have a partner who has no clue about FP7, but has specialist knowledge. Having partners from the north, south, east and west again is great in case it makes sense for the project. Sometimes it just does not as the expertise and experience is in two-three countries. You have to find another way of ensuring European coverage. Invite aboard a relevant association, umbrella organisation or a network with wide membership.

Towards the end of FP7 I think the focus of having as many new organisations involved as possible shifted to a long list of references needed to win an FP7 project. This shift supports the already top 50-100 organisations involved in FP7 to win the projects investing less effort. So, before Horizon 2020 starts, check the list of organisations winning most of the projects relevant to your project idea and get one-two of them on board to have a chance of winning. #### Social inequalities in health in Poland

Tackling inequities in health is a public health challenge gaining increasing prominence in Poland, as elsewhere. Effective policy responses are complex and demand the development of intersectoral, long-range strategies informed by evidence, along with whole-of-society approaches and strong international cooperation. This study presents a first comprehensive summary of the current knowledge on the scale of health inequalities in Poland, the measurement methods used to assess them, and the risk of health inequalities in different age groups, populations and regions. The numerical data are supplemented by numerous accounts of preventive initiatives aimed at tackling health inequalities. The study covers the determinants of inequalities at both macro and individual levels, and looks at two specific populations, children and adults. It ends with a set of recommendations on strategy and policy formulation, monitoring and coordination, on actions to improve the socioeconomic status of the population, and on public health interventions. This study is an important step in realizing the health potential of the Polish population and in contributing to a more fair and sustainable society, thereby reflecting the key values and goals of the new European policy for health, Health 2020.

#### European action plan to reduce the harmful use of alcohol 2012-2020

The European action plan to reduce the harmful use of alcohol 2012–2020 was endorsed by all 53 Member States in the WHO European Region in September 2011. It includes a range of evidence-based policy options to reduce the harmful use of alcohol. This publication also includes WHO Regional Committee for Europe resolution EUR/RC61/R4, a list of indicators (with definitions) linked to the indicators used in the European Information System on Alcohol and Health, and a checklist or set of questions for Member States. The action plan is closely linked to the 10 action areas of the global strategy to reduce the harmful use of alcohol adopted by the World Health Assembly in May 2010. The primary audience for the action plan is the national authorities in the WHO European Region responsible for alcohol policy, mainly the health and other ministries (including finance, education, social welfare, transportation and criminal justice), nongovernmental and civil-society organizations, researchers, the private sector and international partners.
