## Tackling global warming will improve health, save lives, and save money

A very recent study released in JAMA (Climate Change: Challenges and Opportunities for Global Health) provides a very thorough review showing how climate change affects human health. Perhaps more importantly, the paper also describes how tackling climate change leads to many health and economic benefits.

## Living near the coast linked to increased physical activity

A team of researchers at the University of Exeter Medical School found that living near the coast is good as it promotes health and well-being by encouraging physical activity and lowering stress, leading to an overall good health. To prove the hypothesis, they focused on participants across England and described a noticeable effect on western, not eastern, coasts of nation.

# Rising energy drink consumption may pose a threat to public health, says WHO

Energy drinks: the beverage that manufacturers claim can boost physical and mental performance. Many of us drink them, and many of us think they are harmless. But in a new review, researchers from the World Health Organization claim increasing consumption of energy drinks could pose a threat to public health. The number of emergency department visits involving energy drinks doubled between 2007 and 2011, from 10,068 visits to 20,783.

A new study claims that social media sites, such as Facebook, may contribute to marketing of unhealthy foods to adolescents and young adults. The research team, including Becky Freeman, PhD, of the University of Sydney in Australia, publish their findings in the *American Journal of Public Health*. Concerns have been raised about the marketing of junk food in the past, particularly when it is aimed toward children and adolescents.

## Everything you always wanted to know about European Union health policies but were afraid to ask

What does the European Union mean for health and health systems? More than one would think. The EU's health mandate allows for a comprehensive set of public health actions. And there are other EU policies, though not health related, which have important consequences for governing, financing, staffing and delivering health services. In other words: EU actions affect the health of Europe's population and the performance of health systems.

Given how important health systems are, we need an informed debate on the role of the EU and its contribution. But this is not easy because EU health policy is difficult to comprehend. There is no single strategy with a neat body of legislation implementing it; rather, there are many different objectives and instruments, some of which appear in unlikely places.

Understanding the EU role in health is especially important now, when health systems have to deal with a plethora of challenges, the European social model is confronted by the threat posed by the financial crisis, and the EU is facing increasing euro-scepticism in politics.

This short book makes EU health policy in its entirety (and complexity) accessible to political and technical debate. This book is aimed at policymakers and students of public health and health systems in the EU who want to understand how the EU can add value in their quest improving population health and the performance of health systems in Member States.

## **Tackling Health Inequities: From Concepts to Practice**

Despite remarkable health gains, inequities persist between and within countries in the WHO European Region, and Sweden is no exception. Actions to effectively tackle health inequities need to be carried out at all levels of government. Regions have a key role to play because they are close to their populations and have the power and skills to develop efficient public health policies that may help to reduce health disparities by changing the distribution of the social determinants of health. This report describes the process that the Region Västra Götaland, Sweden followed to mainstream health equity in its regional health plan; this resulted in the adoption of the Action Plan for Health Equity in Region Västra Götaland. This publication give an account of not only the factors that made the Action Plan possible but also the obstacles encountered and the measures taken to overcome them. The report illustrates how the whole-of-government and whole-of-society approaches central to the new European health policy, Health 2020, were implemented in a real setting.
