## Outline:

The opening session of the European Public Health Week 2025 will set the stage for an engaging and impactful discussion on how innovation can strengthen resilience and shape a sustainable future for public health in Europe.

- 15:10 European Public Health Week 2025 and its theme: "Innovation for Resilience: Shaping a Sustainable Future.", (2) overview of the importance of resilience in public health, highlighting recent global and regional challenges and (3) introduce the panellists.
- 15:10 This will be followed by two brief interventions from:
- Yuliia Ovchar, a speaker from Ukraine: <u>Reflection on the role of</u> innovation in maintaining healthcare services during crises and



- Irina Mateescu, a speaker from Romania: Lessons learned from past public health emergencies and the need for adaptive, sustainable <u>health systems</u>.
- 15:20 Nicu Ștefănuță will explore how (1) innovation, resilience, and sustainability
  intersect in shaping the future of public health. His address will also highlight
  the (2) European Parliament's role in advancing policies that support robust
  health systems across the continent. Afterwards, he will introduce the next
  speaker.
- 15:25 Raed Arafat will (1) address the crucial link between crisis management and
  sustainable health system development, illustrating how (2) emergencies can serve as catalysts for long-term improvements. He will (3) emphasize the need for continuous investment in health security measures, including digital health solutions and emergency response frameworks, to safeguard populations against future crises.
- Hans Kluge will follow with a discussion on (1) the broader European
  perspective on health resilience. He will outline the (2) WHO's approach to strengthening health systems through innovation, policy integration, and international collaboration. His address will stress (3) the interconnection between health security, prevention strategies, and technological advancements, reinforcing the need for a comprehensive and coordinated approach at the regional and global levels.
- 15:35 Lorena Boix will highlight the (1) EU's investments in health innovation,
  research, and digitalization, showcasing how these initiatives contribute to long-term system stability. Her remarks will also touch on the (2) importance of public-private partnerships in ensuring that health innovations are both accessible and effective in meeting the diverse needs of European populations.





- 15:40 Laurent Muschel, will take the floor to speak on the vital role of
  preparedness through medical countermeasures. He will highlight the
  importance of ensuring that Europe is equipped with the right tools—
  vaccines, diagnostics, treatments, and stockpiles—to respond quickly to the
  next health crisis. His intervention will focus on how strategic foresight,
  coordinated procurement, and public-private collaboration are essential to
  building a secure and responsive health union. He will underline HERA's
  mission in strengthening Europe's capacity to detect and respond to serious
  cross-border health threats by aligning innovation with operational

  will reflect on the vital role of disease surveillance, data sharing, and risk
  communication in strengthening Europe's health resilience. She will highlight
  how innovation in public health intelligence, supported by digital tools and
  real-time data platforms, enables faster and more effective responses to
  emerging threats. Her remarks will underscore that health security is not a
  fixed outcome, but a continuous process that requires robust systems,
  strong institutions, trusted partnerships and a whole-of-society approach.
