

HIA in Andalusia




Process

HIA in Andalusia: Success factors


- ✓ **Sustained strong political support**



What is Strategic Foresight

- Strategic foresight is a **proactive and systematic approach** to envisioning **different futures, challenges, and opportunities**
- **Policy making is about the future** (so better to know what possible futures we are facing)
- Foresight-informed policy making in the face of **uncertainty**, ensuring **resilience and preparedness** for societal, technological, environmental, and economic changes
- Includes various methods like horizon scanning, scenario building, stakeholder participation, modelling
- We **don't predict** the future but merely explore possible futures

Foresight study: no blueprint, common elements


What future are we facing?



What are the most important challenges?




What are the options for action?





Strategic Foresight at RIVM

- Dutch Public Health Foresight Study
 - Since 1993, legal basis
 - Time horizon +25 years
 - Input for policy process (MoH, local policy makers)
 - Intensive stakeholder participation process
- To gain insights into the most important challenges for **policy and society**
- From scenarios to challenges to **options for action**
- *“Looking into the future to change the present”*


