## An operating grant & action grant

### Operating grant

*Call: financial contribution to the functioning of health nongovernmental bodies implementing one or more specific objectives of the EU4Health Programme.* 

### ✤ Action grant

Call: for developing a pilot project for an EU infrastructure ecosystem for the secondary use of health data for research, policy-making and regulatory purposes.



### Key message

Operating grants are an essential tool for health organisations in Europe, like EUPHA, to ensure:

\*participating in the health debate,

- \*making sure an independent voice of the health community is heard, and
- \*taking part in the health policy making process.



## Who is EUPHA

The European Public Health Association (EUPHA) is the umbrella organization for public health associations and institutes in Europe.

EUPHA is an international, multidisciplinary, scientific organization, bringing together over 39,000 public health professionals for exchange and collaboration throughout Europe and responsible for organizing the largest annual public health event in Europe.

- Eligible costs: general management costs, general running costs, including personnel costs.
- Recognised as playing a major role in the field of health, and specially public health, at Union, national and local levels.



# Operating grant = good investment for public health (1/2)\*

\*Operating grants ensure long-term sustainability and capacity for health non-governmental organisations.

\*Operating grants allow health NGOs to directly add value by connecting and building bridges:

- Action: listening and amplifying the voices of communities, as well as the NGOs' members and partners
- Action: incorporating their stakeholders' voices into the policy discussion, and by partnering in policy implementation
- Action: running initiatives on the ground on national and regional level.



# Operating grant = good investment for public health (2/2)\*

- These actions require a stable organization, and operating grants have proved a worthy enterprise, offering stable and predictable funding to NGOs
- It is our direct experience that the operating grants remain a valued mechanism in the EU health policymaking to ensure adequate funding for NGOs and enable their role in the health debate, making sure that the voice of the most vulnerable is heard.
