The European Public Health Association (EUPHA), is an umbrella organisation for public health associations and institutes in Europe.

**Our vision** is of improved health and well-being and narrowing health inequalities for all Europeans. We seek to support our members to improve health in Europe, adding value to the efforts of stakeholders in regions and states, in national and international organisations, and individual public health professionals.

**Our mission** is to facilitate and activate a strong voice of the public health network by enhancing visibility of the evidence and by strengthening the capacity of public health professionals. Sustainable advancements in public health and health services can only be achieved through collaboration. EUPHA is dedicated to **working in partnership** with European and international intergovernmental and non-governmental organisations as well as national institutes and organisations that are aligned with EUPHA's values and commitment to improve current and future health in Europe.

#### 1. Full membership

Full membership of EUPHA is open for national public health associations in Europe (WHO/EURO definition of Europe). National associations need to be scientific and have a multidisciplinary approach to public health.
