Through insightful interviews with EUPHA's section leaders; I was able to gather expert opinions on what are the core competencies for public health officials.

My visit to EUPHA's office in Utrecht was particularly insightful, affording me the opportunity to witness the commendable work conducted there and to appreciate the motivating and positive work environment that is fostered. Overall, this internship significantly enhanced my research, writing, and communication skills. It also provided practical exposure to conducting interviews and qualitative studies.
