On behalf of the EUPHA Executive Council, it is my pleasure to present you this report summarizing our activities in 2015.

This is been a very busy, a very challenging, and above all a very successful year. We had a superb conference in Glasgow, with a record attendance, and an absolutely outstanding programme. Our new, more interactive, formats for plenary sessions were especially popular. We have seen a growth in workshops, allowing delegates to focus in depth on key issues of importance to them, to build their skills, and to exchange ideas for policy and practice. Our late breaking session give us an opportunity to exchange the most recent knowledge on the ball crisis and events in Ukraine.

We have changed our image. We have a new website and a new logo. This may seem simple, but the work involved should not be underestimated. Our website is not only more attractive, it is also much easier to find one's way around.

We have stepped up our involvement in advocacy substantially. We now have a much more streamlined system for reaching agreement on statements so that we can react in a timely way to emerging events. Later in this report you can see the range of issues that we have spoken out on. We hope that we have been able to represent your views fairly, but do tell us that there are more things that you feel we should be doing. This is one of the many areas in which we also need your help. We hope that you will take our statements and make use of them in your national media. And please do remember, EUPHA is here to help you. Where there are particular concerns in your own country that you feel it would be helpful for us to add our voice to yours, please tell us. It can sometimes be very effective to bring an international voice into the debate. On the other hand, we understand that it can also be unhelpful at times so you should decide when our voice might be helpful.

Our journal goes from strength to strength. I want to thank Peter Allebeck and his team for the remarkable job that they do, showcasing the best research from Europe. They have taken the journal forward in many ways, including a very active editorial policy to encourage commentaries and debates. Now that I am a (relatively frequent) author and no longer the editor, I have seen at first hand how smoothly the editorial process works, much better than with many other journals. Our newsletter contains a wealth of information and I know that it is widely read.

Later on in this report I have set out our ideas for 2016. We have an ambitious programme. However, it builds on a record of sustained achievement.

This would not have been possible without the exceptional work of the team in the EUPHA office. I would pay particular tribute to Dineke, who despite illness this year, has taken us onward and upward. I also want to thank Floris, who has unexpectedly had to take on many more duties this year and who has risen to the occasion superbly, as well as the rest of the team in the office for all that they have done. However, this year we have special thanks to Peter Groenewegen and Judith de Jong, at NIVEL, who have gone beyond the call of duty to support the EUPHA office.

We can only succeed in what we do because we have the support of so many willing volunteers. In particular, I want to thank the members of the Executive Council, the section presidents and vice presidents, our pillar leads, and our EUPHAnxt coordinators. All of them put in a remarkable amount of effort throughout the year. We are indeed fortunate to have such a fantastic team. But finally, I want to thank you members, because without you we could do nothing.

European public health will be tested in the coming year. Together, we can be strong. Let's work together to make a confident a healthier, safer, and better place for everyone.

We have again been very busy this year and this is reflected in this report. We continue to successfully host the EPH conference office and were happy to organise the rebranding of EUPHA with a new logo and a completed revised EUPHA website as well as start the implementation of the new EUPHA strategy.

The new EUPHA strategy 'Voicing knowledge. Enhancing capacity.' focuses on three objectives:

- 1. Be a leading voice in public health.
- 2. Build capacity and knowledge.
- 3. Invest in future generations.

Under the pleasant and strategic guidance of the Executive Council, we have again joined forces with our 20 sections, Four pillar leads and our members to start implementing the new strategy. Our representatives were at the heart of European policy discussions and our sections and members continued to provide the evidence-base which is the core of our strength.

We were fortunate to have the office team strengthened by our new office manager, as well as by the EUPHAnxt coordinators, Ms Tjede Funk (February-July), Ms Emma Honkala (August-now). We were also pleased to see that our former EUPHAnxt coordinator, Dr Giacomo Scaioli, continued to be active for EUPHAnxt, the conference and the EUPHA newsletter. On the other hand, the long sick leave of our Executive Director, forced us to prioritise some activities and – unfortunately – postpone others.

Be a leading voice in public health

One of the key activities to further develop within the new strategy was for EUPHA to become a leading voice in public health. In 2015, thanks to the initiatives of our president, Martin McKee, we managed a large number of activities in this area.

Where possible the EUPHA sections and the EUPHA members were included and in some cases, our members took the initiative.

The activities included, but were not limited to:

The increasing refugee problem in Europe

Together with our EUPHA section on migrant and ethnic minority health, EUPHA reacted several times (May-July-October) to the humanitarian crisis in the Meditarranean, calling on public health professionals to speak up. At the conference in Milan 2015, the theme is also included in the Late breaker session.

Health on global climate conference agenda

At the initiative of the French Society of Public Health, EUPHA co-signed the open letter to the French Minister to include health on the agenda of the Global Climate Conference, planned in Paris in December.

TTIP EU – US negotiations

At the initiative of the UK Faculty of Public Health, EUPHA expressed concerns about the EU-US Transatlantic Trade and Investment Partnership negotiations, which could seriously impact health.

Trade secrets

Following a call from other NGOs, EUPHA joined these NGOs in concerns for the EU Directive on trade secrets, which pose a threat to public health data.

Data protection and health research

The EUPHA Sections on Health Services Research and Public Health Monitoring and Reporting continued to address the negative consequences for public health and health services research of the EU Data protection regulation.

Food marketing

EUPHA joined other European health-based NGOs in supporting WHO Europe's plans to restrict food marketing to children.

Tobacco and vaping

In January, EUPHA published a EUPHActs expressing concerns about the uptake in vaping.

Build capacity and knowledge

EUPHA continues to build capacity and knowledge wherever possible. The successful tools of EUPHA are the European Journal of Public Helath, the EUPHA sections, the newsletter and the conference.

The visibility of EUPHA as a solid partner with a research background has been strengthened. Activities were aimed at WHO Europe and the European Union (both Commission and executive agencies such as ECDC and the Joint Research Centre). EUPHA continues the build the capacity and knowledge of policy-oriented organisations and has an official seat in:

- EU Expert panel on effective ways of investing in health;
- WHO Europe Advisory Committee for Health Research;
- Advisory forum to the European Centre for Disease Prevention and Control; WHO
- European Regional meeting; and
- APHEA board.

Furthermore, EUPHA remains one one of the leading associations (together with EHMA and HSR Europe) is to set up an ERAnet on public health and health services research.

Invest in the future generations

The third objective is to prepare future generations of public health professionals to take on a leadership role. The activities to reach this objective are in the hands of the EUPHAnxt network and of course, the EPH Conference is a great tool to invest in future generations.

The EUPHAnxt team has been very active this year and activities include, but are not limited to:

- Participation in the 'Global Health Next Generation Network' conference in Barcelona in June 2015: <u>www.globalhealthngn.org/#!conference/cut9</u>
- Participation at the 'Giornate degli specialissandi', a congress of the Young section of the SItI in Milan in March 2015. - Participation in the WHO simulation in Paris, co-organised by our instutional member EHESP. Participation included having a stand at the fair that took place before the simulation: <u>http://pariswho.org/</u>

Other activities included:

- Organising a skills building workshop at the Milan 2015 conference
- Establishing official partnership agreements with the Global health Next generation network and the European Medical Student Association
- EUPHAnxt flash the newsletter for the EUPHAnxt subscribers was sent in March and June (and planned in October)
- EUPHAnxt mailman a system to reach all subscribers was used extensively this year to inform the younger generation on courses, activities, internship, etc.
- Continuing the internship programme where some students were put in contact with relevant public health professionals.


Public Health Perspective Nepal

The network

In our database, we have 16'448 entries of which 5935 are EUPHA members (36%). This is both an increase in numbers (+363) and an increase in percentage (from 35 to 36%). Full members of EUPHA are individuals who joined EUPHA through their membership in a national public health association. In 2015, we had 4764 (up from last year by 395 members) of these full members.


Website

Social media

The EUPHA twitter account (@EUPHActs) is available on our opening page and has been extensively used for advocacy. The number of followers has increased again in 2015 to 1207 (2013: 384; 2014: 821).

The twitter account is also linked to our Facebook page, where further development, however, is still desirable.

EUPHA sections

EUPHA sections are networks on specific public health topics. At the moment, EUPHA has 20 active sections and one initiative for a section on gender minority health. The average number of members in a section's network is 1104 (last year 990). EUPHA sections organize different activities throughout the year that range from:

In Milan 2015, the EUPHA sections are organising/co-organising:

- 6 pre conferences, with 8 sections involved;
- 21 workshops, with 17 sections involved;
- 1 lunch meetings by 1 section;

And all sections are organising their annual meetings before and during the conference. This year is the first time that we actively invite delegates to 'join our network' during the annual meetings.

EUPHA pillars

At the end of 2013, it was decided to re-launch the Four Pillar networks of EUPHA. Four new pillar leads were found and an invitation to our members and the sections to propose representatives was sent out.

The objective of the EUPHA pillars is to have specific networks set up for Research, Policy, Practice and Training and education, where representatives from EUPHA members and EUPHA sections discuss activities developed or to be developed by EUPHA.

EUPHAnxt

EUPHAnxt is a network for students and early career researchers, policymakers and professionals in the field of public health. EUPHAnxt is a free and open initiative that aims to collect the active contribution of students, young researchers, practitioners and policymakers interested in European public health issues, in order to sensitize and involve them into the European and multidisciplinary network of public health associations.

The EUPHAnxt network currently has 1087 subscribers (in 2014: 790). Activities include:

- Advising students on possible internships;
- Networking with other student-related organisations;
- Contacting members on their activities for the younger generation;
- Organising one skills-building event during Milan 2015.

European Journal of Public Health - EJPH



The European Journal of Public Health is a multidisciplinary journal in the field of public health, publishing contributions from social medicine, epidemiology, health services research, management, ethics and law, health economics, social sciences and environmental health. The EJPH is published bimonthly. The journal provides a forum for discussion and debate of current international public health issues with a focus on the European region. In each issue of the EJPH, EUPHA organises the European public health news, a section of the EJPH with contributions from the EUPHA president; EUPHA office; WHO Europe's Regional Director; European Commission; and the EPH Conference Foundation.

Brief statistics on manuscripts

During the past year (1st October, 2014 to 29th September 2015), manuscripts have been submitted from 67 countries from all continents. The highest number of submissions was received from Spain (70), China (67), Italy (66), Netherlands (66), United Kingdom (63), Sweden (43), Germany (42), France (36), Finland (32), United States (28) and Denmark (25).

The highest number of accepted papers originated from The Netherlands (29), the United Kingdom (19), Sweden (16), Italy (15), Spain (14), Germany (11) and Finland (11).

In addition to original manuscripts, 12 editorials and 8 Viewpoint articles have been published from December 2014 – October 2015. Each of the six issues also had a section with European public health news from EUPHA and partner organisations.

Reviewers

During the past year (2014), 622 persons from 66 different countries have been helpful in reviewing manuscripts. Most reviewers originated from the United Kingdom (74), followed by the Sweden (73), Netherlands (57), the United States (49), Spain (39), Germany (37), Denmark (36) and Italy (35).

Impact factor

The impact factor increased this year to 2.591 with a five-year average of 2.805.

EUPHA Projects in 2015

EUPHA continues to be contacted by a large number of institutions/universities to be a partner in European projects.

Projects started in 2015

Gender specific mechanisms in coronary artery disease in Europe (GENCAD)

The project aims to provide novel explanations as to why and how different forms of CAD affect women and men and which preventive approaches are most effective in a gender specific manner. The project aims at closing a gender gap in European medicine by systematically collecting information about differences among women and men in CAD at all levels – biological, societal, environmental – and by generating awareness among health professions and the general public.

EUPHA's tasks:

- Development of factsheets by contracted writer/editor
- Assessing member state policies and existing preventive approaches by member associations
- Informative meeting at EPH Conference, Milan

DG SANCO tender project for 3 years. Consortium with Charite University (DE), School of Public Health, Andalusia (ES), Radboud MC (NL), Centre for Men's Health, Leeds (UK)

Personalised prevention of chronic diseases (PRECeDI)

The project aims to Identify and validate biomarkers for primary prevention of cardiovascular diseases (CVD); secondary prevention of Alzheimer (AD); tertiary prevention of head and neck cancer (HNC);

The project is funded under the Marie Curie Programme of Horizon 2020. Future PhD students at the partners' universities will be seconded to other universities, institutes or private companies. EUPHA will host 3 researchers for 6 months in 3 consecutive periods from UCSC, Debrecen and La Sapienza.

PRECeDI is a consortium of 11 organisations of which 7 are academic institutions and 4 non-academic. The project duration is four years.

EPH Conference

In 2013, the separate foundation 'EPH Conference' was set up to coordinate and organise the European Public Health Conferences at the initiative of EUPHA. EUPHA still provides the main input for these conferences, and collaboration has been set up with a large number of international NGOs and international organisations, including:

- EuroHealthNet
- ASPHER
- EHMA
- EPHA
- ECDC
- European Commission
- Observatory
- WHO Europe

All these partners are represented in the advisory International Conference Council, where main topics, themes and possible keynote speakers are discussed. They are also all invited to provide experts for the International Scientific Committee, responsible for the scoring of the submitted abstracts and workshops.

Glasgow welcomed Europe and beyond to the 7th European Public Health Conference between 19 and 22 November 2014. Seventy-one countries were represented by over 1,500 delegates. The conference included seven plenary sessions, over 100 parallel sessions, about 300 posters and six films. The conference resulted in the Glasgow Declaration 'ALL HANDS ON DECK!' in which the public health community and the whole of society is called upon to be more involved in reducing health inequalities.

Milan 2015

Outlook 2016

It is already clear that 2016 will be extremely challenging year. This year, the European institutions have been shaken to their core. Two of the fundamental symbols of the European ideal, the euro and the Schengen agreement, have come under unprecedented strain. They have survived, but only just. Improving the health of the population should be one of the primary goals of political leaders but, in many countries, public health has been relegated. As we move forward into 2016, EUPHA is determined to do everything that it can, working with our members and our European partners, to influence the debate on the future of Europe.

We will continue to advance our first objective, to be a leading scientific and independent voice in the field of public health, health services research and policy. We have stepped up our advocacy activities considerably in 2015, calling for effective action on some of the major challenges facing Europe, such as the refugee crisis. However, we cannot do all of this on our own, and we need the support of our members. Some are already active in advocacy at a national level but at times like this we must all speak out. Recognising our limited resources, we will do what we can to help those who wish to take on a greater role in advocacy. We also recognise that there are many fantastic initiatives in public health across Europe but these often go unnoticed. EUPHA provides an opportunity to showcase these ideas. Please tell us how we can help you to do that on a wider European stage.

We must be involved in setting the European public health agenda. Several of us in the Executive Council are active in a number of policy arenas, including the European Commission's Expert Panel on Investing in Health and as participants in the WHO EURO Regional Committee. In 2016 we plan to undertake a survey of members and sections to identify your priorities for the European public health agenda. We recognise that the concept of health in all policies, while endorsed by the European Union and its member states, too often seems to be forgotten. Where are the health impact assessments of the bailouts or the response to the refugee crisis? We plan to map the activities of the European Union Directorate-Generals that impact on health. We recognise that we must work in partnership to bring about the changes that we want to see.

In the past year we have greatly strengthened our relationships with the European Public Health Alliance and the World Federation of Public Health Associations. We have begun a collaboration with the World Heart Federation. We are reaching out to other European health NGOs. We plan to hold joint meetings several times each year with our key allies. We also recognise that many of the influences on public health in Europe arise at a global level. We must make sure that Europe's voice is heard on the global stage. We began this process at the World Public Health Conference in Kolkata in February. It was notable how poorly Europe was represented there compared to, for example, Asia and the Americas. As we

move forward, we will increase our presence in these fora, with the past presidents playing an important role, drawing on their wealth of experience.

Our second objective is to build capacity and knowledge in the field of public health and health services research to support evidence informed policy and practice. We will explore how we can build the capacity and knowledge of our member associations, helping them to become a strong and growing network. To achieve this we plan to organise a member survey, looking at their activities, strengths, weaknesses, and what they expect from EUPHA. As importantly, we will ask what they can offer to EUPHA, recognising that some of our members are themselves very strong, with a wealth of expertise that they can share.

Transparency is key to public health policy. Many of the challenges we face are because decisions are taken behind closed doors by powerful vested interests. We need to set a good example here and we will look at how we can update the Good EUPHA practice rules to showcase transparency.

There are still some countries where public health associations are weak or non-existent and where we have no presence. We are convinced that a strong public health association can make a major contribution to a country, developing, implementing, and disseminating new ideas, holding governments to account, and improving the health of their fellow citizens. We will do all we can to support such associations to emerge when they do not yet exist.

The European Public Health Conference is now becoming the place to be to exchange ideas on health policy and practice within Europe. It provides a great opportunity to showcase the latest research. However it also offers a wonderful opportunity for exchange of ideas and we will work to strengthen the engagement of our members and sections in the conference programmes, in particular by encouraging the submission of workshops meeting the needs of those attending. Finally, we will look for opportunities to translate research into policy and practice outside the conference.

The third objective is to prepare future generations of public health professionals to take on a leadership role. We want to strengthen the role of EUPHAnxt, adding a representative to our Executive Council, and establishing a General Assembly. Our fledgling internship programme has already been a great success, although relatively few have been able to benefit from it. We want to look at other ways to expand this, for example by using funding from the ERASMUS programme. Our conference is a great opportunity to build skills in the next generation and we will build on what we have already been doing.

This is a very ambitious agenda. We have a superb team in the EUPHA office, led by Dineke and with tremendous support from Floris and the rest of the team. However we cannot achieve all of this our own. We will need full engagement from our members and sections. We can help you but you can help us. Let's move forward together.
