

Summary

On behalf of the EUPHA Executive Council, it is our pleasure to present this report highlighting EUPHA's key activities in 2023. EUPHA, with the support of its members, sections, young professional network (EUPHAnxt) and partners engaged in a large number of activities, aimed at building capacity and strengthening the voice of public health professionals and bringing the evidence into the policymaking process.

The importance of public health in 2023

With the continuing war in Ukraine and additional conflicts that the European region is facing in 2023, EUPHA can only condemn these actions, not merely from a humanitarian perspective, but also by perceiving peace as the basic necessity for the public's health.

We continue to learn from the COVID-19 pandemic and make use of the momentum to ensure that in future we will be better prepared for a pandemic or any other health emergency. New structures are put in place to improve our preparedness and response, including, at global level, the pandemic treaty, and the European Union (EU) establishing the Health Emergency Preparedness and Response Authority. We follow these developments closely and provide input on how these structures and mechanisms should be shaped. At our very own conference, the 16th European Public Health Conference in Dublin, Ireland taking place 8 till 12 November 2023 (EPH2023), there are also several sessions dedicated to lessons learned and future preparedness.

EUPHA remains a science-based organisation, recognised as an independent and trusted voice of and for public health. EUPHA is the go-to organisation for science advice on public health! The European Journal of Public Health, the European Public Health conferences, and the EUPHA sections are essential tools here. The European Journal of Public Health is in the top 25% of journals (Q1 SJR), which is a pleasant new development. At the 16th European Public Health conference EUPHA (co-)organised a dazzling number of 110(!) sessions, thanks to the active contributions from EUPHA sections and EUPHAnxt.

'Public health: Global issues, local actions' was the overarching theme of the 2023 European Public Health Week, which is a EUPHA initiative, and this year being the fifth edition. This year's Week a total of 224 events in 39 countries were organised, showing that the Week is truly a week for the whole of the European region and beyond.

The long-wished-for mentoring programme kicked-off in 2023. The physical distancing measures and very limited in-person networking activities during the COVID-19 pandemic, resulted in young professionals having near to zero networking opportunities. Noticing this impact and our young professionals' network requesting to 'get back in the game' as well as make up for the missed networking time, the EUPHAnxt mentoring programme started. The interest was tremendous, with over 160 young professionals applying.

Continuing our activities following <u>our triple A strategy</u> (<u>A</u>dvocating for public health, from a scientific <u>A</u>nalysis basis, and by taking <u>A</u>ction) is supported and acknowledged through the operating grant that we received from the European Union's Health Programme. We feel thankful for being awarded this grant, which co-funds 60% of our activities in 2023, and it allows us to continue to invest in the public health community. Unfortunately, there are currently no perspectives on continuing this very important funding scheme and together with other health organisations, <u>we've called for reinstalling this fund</u>, as these grants allow health civil society organisations to efficiently and sustainably support EU policy making while guaranteeing their independence from vested interests.

2023 is also the year in which we take forward our long-standing collaboration with the World Health Organisation Regional Office for Europe and formalise our partnership in a memorandum of understanding (MoU). The MoU's basis is synergising our efforts for public health, including uptake of evidence in policy and decision-making. Topics for collaboration (to be re-assed every other year) include mental health; behavioural and cultural insights; health

equity, social and economic determinants of health, and investment for health; strengthening the public health community; primary care; and non-communicable diseases. A new step of this MoU is also to connect more with local stakeholders through the WHO Healthy Cities and Regions Network, in alignment with the long-lasting evidence showing how important the local levers are to promote people's health : air quality, physical activity, housing, urban planning, accessibility, access to health care, inclusivity, climate resilience...It aligns with the EU Urban Agenda, and with the Health in All Policies, Health for All Policies approach.

Change of executive director

2023 saw a change in the leadership of the EUPHA office with Marieke Verschuuren stepping down as Executive Director and Charlotte Marchandise joining as the next Executive Director.



EUPHA's key activities

We structure this annual report according to the 8 goals as listed in the 5-year work plan belonging to the EUPHA strategy 2020-2025:

Goal 1: Support our members in their work at the national, regional and local level

We continued to collaborate with our members. With this year having a 'tripping forward' session the day after our annual meeting of members (Governing Board meeting), hosted by one of our members, the Dutch Federation for Health, in which members can share experiences with running a national public health association and reaching advocacy goals. During the session two cardboard pillars will be filled with offers and requests from national associations, which will be the basis from which EUPHA as the umbrella organisation, can twin organisations for mutual learning. Throughout the year continuous professional development content was uploaded on the EUPHA Learning and resources module, including skills building seminars from the European Public Health Conference 2022 (EPH2022). And our members actively participated in the fifth European Public Health Week (EUPHW), which took place between 22 and 26 May 2023, and was again very successful with 224 events in 21 languages across 39 countries.

Goal 2: Consolidate and expand the partnership

In 2023, we continued our partnerships with the European institutions and agencies, most notably WHO Europe, the European Commission, HERA, ECDC, and EMA. Throughout the year we interacted with Health Emergency Preparedness and Response Authority (HERA) by participating in its civil society forum, in which we provided input on the future of HERA and its mandate. With the World Health Organisation Regional Committee for Europe we formalise our long-standing collaboration with a memorandum of understanding (see previous page 'importance of public health in 2023'). And we continued to be represented at the ECDC Advisory Forum. Through collaboration with other civil society organisations in the field of health, we found synergies to make our cause for public health and make change happen, including with Association of Schools of Public Health in the European Region (ASPHER), EuroHealthNet, European Public Health Alliance (EPHA), European Health Management Association (EHMA), and the World Federation for Public Health Associations. And with the European Observatory on Health Systems and Policies and European Cancer Leagues (ECL) as daily partners, we had another successful European Public Health Week.

Goal 3: Stimulate and facilitate mutual learning

The need for continuously enhancing capacity remains a priority for EUPHA. EUPHA and its sections and partners organised 109 sessions at the 16th European Public Health conference in Dublin, thereby encouraging continuous learning for public health professionals. The EUPHA office welcomed one secondee working in the framework of an EU-funded project to stimulate researchers' exchange in the field of personalised prevention (ExACT project). And the EUPHA sections were actively organising webinars throughout the year (n=11), including a series from the EUPHA Foresight in public health section.

Goal 4: Actively stimulate the younger generation to be part of the EUPHA network

The EUPHAnxt team continued to engage the next generation of public health generation by increasing the information exchange (i.e. newsletters and social media) and offering a new opportunity in 2023, i.e. the EUPHAnxt mentoring programme. An overwhelming number of mentees applied (more than 160). Despite also a good number of mentors (representatives from the EUPHA Section Council, EUPHA Governing Board and EUPHA Executive Council), i.e. n=36, we still had to let down several interested mentees. Groups of three or four mentees are matched with a mentor and the first edition (pilot) of the EUPHAnxt mentoring programme kicked-off in September 2023. The programme will run for six months, after which we will evaluate this new tool. The existing tools of the abstract tutoring programme and the EUPHA fellows at the conference are continued. EUPHA facilitated three internships; covering topics related to public health economics and core competencies, funding opportunities for public health, strengthening public health in the East of the WHO/Euro region, and strengthening the next generation of public health professionals. Last but not least, we co-organised the Young Researchers Forum at EPH2023 with the Association of Schools of Public Health in the European Region.

Goal 5: Keep health a priority on the European and national agendas

We continued being visible at European level by being active both in written advocacy (statements, the European public health news in the European Journal of public Health) as well as participating in European meetings (e.g. the European Alcohol Policy Alliance conference, planetary health round tables and climate change policy debates in Brussels). At the national level, EUPHA supported the letter sent by the UK Faculty of Public Health to the prime minster on Child Food Insecurity; and our strategic advisor participated in the Riga University Research Week 2023 in Latvia and met with the national public health institute to discuss opportunities to jointly improve public health in Europe.

Goal 6: Strengthening public health research in Europe

EUPHA remains a science-based organisation, recognised as an independent and trusted voice of and for public health. EUPHA is the go-to organisation for science advice on public health! The European Journal of Public Health, the European Public Health conferences, and the EUPHA sections are essential tools here. The current impact factor of the journal is 4.4 which remains the same as last year, but a marked increase from 3.367 in 2021. In 2023 the journal moved to a virtual editorial office, after years of support from the editorial team based at Karolinska Institute in Stockholm, Sweden; and we thank them for their efforts and work. This year's European Public Health Conference took place in Dublin, with, again, an impressive number of delegates (over 2,2k). EUPHA sections continued to be extremely active, giving EUPHA visibility all year round. For example, sections were involved in the European Commission's Health Policy Platform Thematic Networks, organised skills-building

webinars, provided input to public consultations and calls for evidence, the EUPHA-LAW section co-organised the Strategic litigation conference in Liverpool, UK and much more.

Goal 7: Deliver the right evidence at the right time

By monitoring what is being discussed at European level, EUPHA managed to publish statements, reactions to public consultations, inputs for calls of evidence, be active on social media and more, which led to more invitations to meetings to deliver the evidence at the right time at the right place (e.g. EUPHA was accepted to the WHO Civil Society Commission). The Rapid Response Team, our mechanism for delivering evidence in a short time-span, was continued and we organised a media training session for this team. The EUPHA Rapid Response Team was activated six times, following media queries on, amongst others, long COVID and mask wearing.

Goal 8: Support implementation of the SDGs and all policies for a healthy Europe

In 2023, the EUPHA Global health initiative was installed. This initiative aims to serve as a platform for the discussion of the theoretical foundations for global health as well as for advocating for global health within EUPHA and beyond. Furthermore, the theme of the 2023 European Public Health Week (a EUPHA initiative) was 'Public health: Global issues, local actions'.

'Our Food, Our Health, Our Earth: A Sustainable Future for Humanity' is the theme of the 2023 European public health conference and the related <u>conference statement</u> urges European leaders to adopt a holistic perspective; legislate for sustainability; promote education and awareness; foster intersectoral collaboration. EUPHA calls on all its members and partners to endorse this statement and stand together to create a food landscape that enriches both humanity and our planet.

As always, we are extremely grateful with the continued support of so many willing and expert volunteers. A big thank you to our section presidents and vice presidents, the EUPHAnxt coordinators and to our members, for their strategic input.

Goal 1: Support our members in their work at the national, regional and local level

Advocacy in support of our members

All member representatives in the EUPHA Governing Board received regular updates on EUPHA statements and public consultations (see under Advocacy) and were asked to further disseminate or co-sign these. One of the more visible statements is the statement about the Ukrainian War, which was quickly followed by EUPHA section statements, notably the EUPHA Children and Adolescent Public Health section and the EUPHA Law and Public Health section. European Public Health Week

The fifth European Public Health Week (EUPHW) took place between 22 and 26 May 2023, and was actively supported by the WHO Regional Office for Europe and the European Commission. The EUPHW aims to connect those who contribute to better public health across the WHO European Region, promote collaboration among the public health community, and boost EUPHA's profile and visibility. The theme and overall purpose of this annual initiative is to join forces for healthier populations. Each day of the week focused on a specific public health theme. For each theme of the EUPHW, there was an official kick-off webinar co-hosted by one of our partners and EUPHA:

- Monday 22 May: Mental health for all Daily partner: WHO Regional Office for Europe, supported by Mental Health Europe and European Commission DG SANTE
- Tuesday 23 May: Diversity in health Daily partner: EUPHA and supported by AGE Platform Europe, the European Federation of National Organisations Working with the Homeless and the European Institute of Women's Health
- Wednesday 24 May: Access to care Daily partner: The European Observatory on Health Systems and Policies
- Thursday 25 May: Prevention and control of chronic diseases Daily partner: The Association of European Cancer Leagues
- Friday 26 May: Global health emergencies and response Daily Partner: The World Federation of Public Health Associations

A total of 224 events and activities in 21 languages across 39 countries were organised – once again showing the tremendous interest for public health across the European Region.

EUPHA members from the Russian Federation

The Executive Council has decided that the membership of Russian associations and organizations will be suspended until the Executive Council is of the opinion that the situation in Ukraine has sufficiently improved. This means that there can be no collaborations with EUPHA at the governing and organizational level. In this way, we keep on supporting individual public health professionals and thus contributing to the Russian people being able to access adequate public health services and execute their right to health.

Goal 2: Consolidate and expand the partnership

As a European organisation, EUPHA continued to invest in strong relationships with our European partners. Yet many of the challenges that we face are global and this means that we work together with global partners as well. We take a broad view not just geographically but also in the issues we engage with, recognising how policies in other sectors can have profound consequences for health. This means that we invest in broad alliances, including not only the 'usual public health suspects', but also partners from other disciplines and sectors.

EUPHA is a deliberately collaborative organisation, meaning that we are always keen to establish partnerships to build stronger evidence and increase the impact of our advocacy. Some of our partnerships are based on formal memorandum of understandings (MoUs) or work programmes, while others are more informal (see box 1).

Goal 3: Stimulate and facilitate mutual learning

The need for continuously enhancing capacity remains a priority for EUPHA. The exchange of knowledge is essential here and EUPHA has the tools to facilitate this. The EUPHA resources module, which was launched in 2021, provides peer-to-peer videos with EUPHA members and partners sharing their experiences with e.g., advocating for public health. EUPHAnxt is a unique network within EUPHA for students and early career researchers, policymakers and professionals in the field of public health. EUPHAnxt is a free and open initiative that aims to collect the active contribution of students, young researchers, practitioners and policymakers interested in European public health issues, in order to sensitize and involve them into the European and multidisciplinary network of public health associations. The EUPHAnxt network currently has 4,037 subscribers (in 2021: 3,383, 2022: 3,790). EUPHAnxt also has a seat in the EUPHA Executive Council to ensure that the voice of the next generation is heard when planning new activities and projects.

Abstract tutoring programme

The successful abstract tutoring programme was continued. Young health researchers could submit their abstract to receive advice for improvement before officially submitting. In total, 25 abstracts were reviewed by 16 reviewers. This is a similar number of abstracts as in 2022 (28).

Of these 25 abstracts, 20 were finally submitted and 18 were accepted (90% and it was higher than in 2022 - 63%). The programme was actively advertised by EUPHAnxt to increase its reach.

European Public Health conference Fellowship Programme

The EPH Conference Fellowship Programme – launched in 2018 by EUPHA and EUPHAnxt – offers students and young professionals an opportunity to participate at the conference with an active role. In 2023, EUPHAnxt received 35 applications from students, young professionals and professionals from Europe and abroad. The gender balance was once again in favour of women. Six selected fellows are given the opportunity to work alongside the EUPHAnxt and the EPH conference teams to disseminate information about the conference through various communication platforms. The fellows also get the chance to have mentoring sessions with senior public health experts. The role of the selected fellows is to follow all sessions on a specific topic of their interest and report on these sessions in the form of short interviews with the speakers. In briefing sessions with the section president from the related topic, the fellows were informed about the ins and outs of the topic. Furthermore, the fellows contribute to the daily podcast named YUPT (Yesterday's Update, Plans for Tomorrow). This YUPT is made available every morning at the start of the conference day.

Mentoring programme

In 2022, a new mentoring programme was developed, which was launched in 2023. Following two years of very limited opportunities for meaningful networking, EUPHAnxt pushed for improving this necessary aspect of professional lives, especially to young professionals. The goal of this programme is to link students and young professionals to mentors, who are themselves established public health professionals. It is an opportunity for experts to share career advice and research-related activities, and for mentees to get to know the European Public Health field and its stakeholders. 163 applicants applied for the mentoring programme, out of which 140 were selected and will start their mentoring journey.

Goal 5: Keep health a priority on the European and national agendas

In 2023 with the support of the Operating Grant, EUPHA continued to engage in a vast amount of advocacy activities at European level. The members of our Executive Council - particularly Iveta Nagyova (EUPHA president), Martin McKee (EUPHA past president) - and the presidents of the EUPHA sections and EUPHA office staff have really stepped up and have been representing EUPHA, providing the evidence for EUPHA statements and done all in their powers to make EUPHA visible at European level. This has resulted in a large number of statements and active participation at key meetings. Below are some highlights of our advocacy work in 2023. <u>EUPHA statement on priorities for the EU4Health Annual Work Programme 2024: more</u> <u>attention for chronic diseases, elderly and young people, health inequalities, and civil society</u> <u>engagement needed</u>

The European Commission has launched a targeted stakeholders' consultation to seek input for the EU4Health Annual Work Programme 2024. Although EUPHA appreciates this opportunity for stakeholders to provide input, we argue that for setting priorities for EU health policy, we need an integrated assessment across sectors building on concepts and measures such as burden of disease, demographic developments, future scenario studies and societal needs. The lack of such an integrated assessment approach results in important omissions in the current set of priorities, including a lack of focus on chronic diseases beyond cancer, addressing the impact of ageing populations and stimulating healthy ageing, ensuring the health of young people and preparing the next generation of (public) health professionals, and tackling health inequalities. Last but not least, among the current priorities there is no acknowledgement of and support for the role of civil society organizations in developing and implementing the EU4Health Programme. Health should be included in impact assessment EU climate target

The European Commission launched a call for evidence in relation to a 2040 climate target for the EU. While economic, social, environmental, and fundamental rights and equality impacts are considered in the call, health impacts are strikingly missing. EUPHA and its Environment and health section argue in their response to the call that both individual and population health should be used more intensively as a strong argument in motivating all sectors and decision makers in taking initiative towards a 2040 climate target. By co-signing this statement, EUPHA has joined the WFPHA in their call on the Ugandan President, Parliament and Government to foster an inclusive and safe environment for all citizens, while safeguarding the human rights of each individual, irrespective of their sexual orientation or gender identity. EUPHA supports civil society call for EU mandatory alcohol labelling

EUPHA joins a major alliance of European civil society leaders in urging senior EU officials and Commissioners to issue a mandatory alcohol labelling proposal as soon as possible. In particular, the alliance calls to

- respect consumers' right to information by issuing a proposal for mandatory on-label provision of energy value, full nutrition declaration, and list of ingredients for all alcoholic beverages (wines, beer, and spirits) as soon as possible;
- ensure that basic nutrition information is available on label for consumers to access • easily at all times and without the need of additional tools and skills.

Labelling of alcoholic beverages is an important measure to implement as part of a broader strategy to fight alcohol related harm, alongside other effective policy tools proposed in the European Beating Cancer Plan, the WHO SAFER recommendations and the WHO European Framework for Action on Alcohol 2022-2025.

EUPHA endorses two joint statements from the 2022 Thematic networks of the EU Health Policy Platform

EUPHA participated in two of the 2022 thematic networks that were hosted on the EU Health Policy Platform and undersigns these:

The 'DisQo anti-discrimination & health equity' joint statement was led by the European Public Health Alliance. The statement addresses that despite increasing evidence showing that structural, institutional, and interpersonal racism and discrimination impact both physical and mental health inequities in multiple ways the issue has gained too little attention in the public health domain thus far. The statement identifies five key priorities for addressing the issue in a constructive, respectful, and participatory way.

The Mental Health in All Policies joint statement was led by Mental Health Europe. This joint statement calls for a Mental Health in All Policies approach, i.e., for public policies across sectors to promote population mental health and wellbeing by initiating and facilitating action within different non-health public policy areas and describes the win-win situation for such an approach.




Figure 1: Overview of X (former Twitter) followers 2014-2023*

LinkedIn & Facebook

In 2023, we started to increase our posting on LinkedIn as we see that many of our stakeholders are active here. With our increased visibility on LinkedIn we also see a steep increase in followers on our EUPHA LinkedIn, which now has 9,014 followers (4,800 followers in 2022 and 2,549 followers in 2021).

The EUPHA Facebook page is not used as extensively as the Twitter and LinkedIn channels. However, high-level announcements are distributed via Facebook, too, and the number of followers has increased since 2021; on Facebook we have 3,600 followers (3,400 followers in 2022, 3,318 followers in 2021).

EUPHA newsletter

The EUPHA newsletter aims to build the knowledge of public health professionals worldwide and to increase the visibility of EUPHA as an association that builds capacity, knowledge and policy in the field of public health, with an emphasis on the European Region. The newsletter is published monthly, free of charge and available to all those with an interest in public health.

With 32,603 subscribers (30,300 subscribers in October 2022 and 27,916 subscribers in October 2021) from 175 countries worldwide, the newsletter continues to be one of the most visible and highly appreciated tools of EUPHA. EUPHA actively invites members and partners to further distribute the newsletter by announcing its publication in their tools as well as encourages them to make the EUPHA newsletter available on their website. This year, we have been more active in sharing the newsletter on our social media, and encouraging more people to subscribe.

Goal 6: Strengthening public health research in Europe

EUPHA has three very successful tools for providing the evidence base: the <u>European Journal</u> <u>of Public Health</u> (EJPH), the <u>EUPHA sections</u> and the <u>European Public Health Conference</u> (EPH).

The European Journal of Public Health



The European Journal of Public Health is a *fully Open Access* international multidisciplinary journal in the field of public health. Among disciplines covered are social medicine and community health, epidemiology, health services research, health policy, ethics and law, health economics, social sciences, environmental and occupational health.

The journal provides a forum for public health science and policy with a focus on the European region. Contributions on relevant global health issues are also welcome.

The journal is part of the Committee on Publication Ethics (COPE).

Brief statistics on manuscripts

The number of original manuscripts received has increased after the dip of submissions in 2022, while the proportion of accepted manuscripts has increased. The last years' strong variations are most probably due to both the COVID-19 pandemic and transition to open access, reflecting changes in the quality of submitted manuscripts. The impact factor increased to over 4 in 2022 and has remained on that level. Although the increase is partly due to a change in method for establishing the impact factor, the fact that is remains on this level is a good sign. Moreover, the EJPH is in the top 25% of journals (Q1, SJR).

In the four issues published in 2023, 109 original manuscripts, 8 editorials, 3 viewpoints, 1 commentary and 1 obituary were published. Each of the four issues also had a section with European public health news from EUPHA and partner organizations.

In 2023 (until September 30), manuscripts have been submitted from 56 countries from all continents. The highest number of submissions with a decision were received from China (84), the United Kingdom (40), Sweden (34), Italy (28), Finland (24), France (23), Germany (23), the Netherlands (21), Spain (19), Poland (14), the United States (12), and Denmark (10).

The highest number of accepted papers originated from Sweden (24), the United Kingdom (23), Finland (17), the Netherlands (16), Italy (12), Germany (12), France (11), Denmark (10), Spain (6), the United States (6), and China (5).

Goal 7: Deliver the right evidence at the right time

EUPHA has several tools to deliver the right evidence at the right time. Timing is of essence, in order for the presented evidence to have an impact.

EJPH tools

In the EJPH editorials and viewpoints were published on current public health issues and every issue of the EJPH contained the European public health news pages with the latest updates from key European public health actors, including ECDC, WHO Regional Office for Europe, and the European Institutes and agencies.

Contributing to the evidence base through European projects

In 2023, EUPHA was involved in a number of European projects and kicked started the work on two new projects; one from the EU4Health programme and one from Horizon Europe (research programme). These research projects focus on a variety of public health issues and receive (co-)funding from the European Union. For a full overview of the EUPHA projects see annex 2.

Rapid Response Team

In order to be able to provide the evidence-base on a large number of public health topics in a short period of time, EUPHA created the Rapid Response Team in 2019. This network of 40 public health experts mainly linked to the EUPHA sections can be contacted when a journalist or policymaker contacts EUPHA to get a response on a question related to a certain topic. This year, the rapid response team came into action several times. Some examples of the responses since January 2023 are:

- The first ever WHO global resolution on behavioural sciences for health was adopted by the 76 World Health Assembly on 29 May 2023. Iveta Nagyova, EUPHA president, contributed to the content of this resolution.
- Research Professional News requested information on travel restrictions imposed by some EU members states but not recommended by the ECDC. An article was produced after response from Ricardo Mexia, EUPHA-IDC section president.
- The Alcohol Labelling Study asked for an interview with regards to a study to evaluate the effectiveness of health information on alcoholic beverages. This was done by Nikhil Gokani, EUPHA-LAW vice-president.

The members of the Rapid Response Team were offered a media training this year, in which experiences were shared with do's and don'ts of engaging with media and presenting to media. The training session was with kind contributions from lecturers from the Escola Superior de Comunicação Social in Lisbon, Portugal.

Goal 8: Support the implementation of the SDGs and all policies for a healthy Europe

The Sustainable Development Goals (SDGs) make the relationships between health and its wider determinants explicit and tangible. Following the COVID-19 pandemic, the importance of global health for the European region is stressed. Fully in line with this goal 8, an initiative for a EUPHA section on Global health was installed. This initiative ensembled interested individuals at the European Public Health conference and aims to serve as a platform for the discussion of the theoretical foundations for global health as well as for advocating for global health within EUPHA and beyond.

'Our Food, Our Health, Our Earth: A Sustainable Future for Humanity' is the theme of the 2023 European public health conference and the related <u>conference statement</u> urges European leaders to adopt a holistic perspective; legislate for sustainability; promote education and awareness; foster intersectoral collaboration. EUPHA calls on all its members and partners to endorse this statement and stand together to create a food landscape that enriches both humanity and our planet.

Outlook 2024 – Preparing for our next strategy for strengthening public health in the European region

We are now well into our triple A strategy, with our <u>A</u>nalysis of the scientific evidence, providing a solid base for our <u>A</u>dvocacy work for evidence-informed, actionable policy-making and that lead to efficient <u>A</u>ctions. Slowly we will have to start thinking about our next strategy for strengthening public health in the European region. That's the plan for 2024.

The new EUPHA strategy will have a totally different starting point, with major challenges that the world has faced in the past years, which were disruptive to public health and our societies at large. The new strategy will lead the way forward based on our experience from the COVID-19 pandemic, war and conflict in the European region, and the reality of climate change.

We will continue being the go-to organisation for science advice on public health matters. In parallel, we will strengthen our voice for public health. Public health needs story tellers, cheerleaders and champions, to guide the way to improving the health of populations. More than ever, the need for strong communicators is visible.

We look forward to implementing the MoU with WHO/Euro, which was signed at the end of 2023. We see a wealth of opportunities in our collaboration, including the creation of links between local/regional/national and international levels for knowledge exchange.

On an organisational level, there will also be focus on ensuring a strong financial basis, in order to continue our work on strengthening public health in the European region. Our independence is key here (see our <u>Code of Good EUPHA practice</u>). The EU operating grants that EUPHA has benefited from the past years have allowed the organisation to be more visible, take more action, and bring the scientific evidence forward for policy and action. Again, here, we express our gratitude for this financial support. It is difficult to understand that this immensely supportive funding mechanism is now stopped, whereas in other sectors, the EU continues operating grants. We will therefore, together with the Executive Council, look into potential new income sources to ensure financial stability for EUPHA in the future.

We are looking forward to yet another exciting year full of EUPHA activities. All this would not be possible without our members, sections, young generation, partners and the EUPHA office team, and the leadership of the Executive Council. We thank everybody for their contributions to EUPHA and hope that we may also count on you in the coming year and beyond.

EUPHA Working Group on Access to medicines

The working group was established in July 2023

All citizens in Europe and beyond should have access to essential medicines that are affordable and of high quality. However, the current laws, rules and processes that regulate access of medicinal products - including vaccines - to the market and determine availability and distribution of these products for patients/citizens, do not always have the desired effects. We see problems such as (extremely) high prices, stock shortages, unequal/unfair distribution - as we have seen e.g., during the COVID-19 pandemic -, market access for medicines with very little added value, and persistently inadequately addressed unmet societal needs (e.g., lack of investment in new antimicrobials and in medicines for neglected tropical diseases). Access to medicines as an element of Universal Health Coverage therefore is an important topic for EUPHA. Currently, several important developments are ongoing that will impact on access to medicines in Europe, most notably the revision of the EU pharmaceutical legislation, the establishment of the Access to Novel Medicines Platform (NMP) by WHO-Euro as an outcome of the Oslo Medicines Initiative, and the development of a global Pandemic Treaty. This means that there is a clear momentum to bring in the public health perspective and make sure that an evidence-based and equitable population health lens is applied in these policy processes. To help EUPHA in their advocacy for this, EUPHA is calling for experts for an advisory working group on access to medicines.

PROPHET

The HealthData@EU Pilot project is the second project joined by EUPHA in 2022. This is a project that is funded through the EU4Health Programme. It aims to set up concrete foundations for the future so-called European Health Data Space for the

secondary use of health data. In 2023, the first year of the project was completed, with several (technical) outcomes, such as a proof of concept for the IT infrastructure. EUPHA contributed, as work package leader, to the dissemination and communication activities. 2023 also marked the start of the second and final year of the pilot project. EUPHA's main role will be coordinating the supplement to the European Journal of Public Health.

ExACT: European network staff eXchange for integrAting precision health in the health Care sysTems

ExACT started early 2019. The exchange project aims to build a community of academic and non-academic entities that generates high quality, multidisciplinary collaboration through exchanging knowledge in research and training activities on precision health. By

building up on the PRECeDI Consortium it will include other relevant sectors in order to strengthen and broaden the research and training activities of the existing network and reinforce the international and intersectoral cooperation. By sharing knowledge, building synergies and expertise and encouraging an exchange of best practice among top-level institutions, it will give impetus to the translational efforts necessary to implement precision health into the EU health care systems. The ExACT project has received funding from the European Union's Horizon 2020 research and innovation programme MSCA-RISE-2017 Marie Skłodowska-Curie Research and Innovation Staff Exchange (RISE). In 2023, the exchanges via ExACT continued, and EUPHA hosted two secondees.

RIVER-EU – Reducing barriers to vaccine uptake in underserved communities

To improve equitable vaccine uptake in underserved communities, a new European research initiative has launched in 2021. RIVER-EU ("Reducing Inequalities in Vaccine uptake in the European Region -Engaging Underserved communities") is a 5-year (2021-2026) project coordinated by the University Medical Center Groningen (UMCG) and funded by the Horizon 2020 Research Programme. Using an

interdisciplinary approach, RIVER-EU will collect evidence on health system determinants of high and low vaccine uptake in eight specific contexts, which will be used to identify and/or develop interventions to reduce barriers to vaccine uptake in underserved communities and increase trust in the health system.
