In order for EUPHA to be able to provide the evidence in a wide array of topics, different **thematic networks** (the sections) were developed to work on specific public health topics. In 2023, EUPHA has a total of **26 operational sections and 2 initiatives**. The sections continue to have a large interest with number of section members rising for all sections.

These sections have been active all year long through **sending regular newsletters** and other updates, **organising events** during the EUPHW and the EPH Conference, and **writing statements**.

For example, sections were involved in the European Commission's Health Policy Platform Thematic Networks, organised skills-building webinars, provided input to public consultations and calls for evidence; the EUPHA-LAW section co-organised the Strategic litigation conference in Liverpool, UK and much more.

# **EUPHAnxt**



EUPHAnxt is a network for students and early career researchers, policymakers and professionals in the field of public health. In 2023, 4,037 subscribers were active in the network.

EUPHAnxt is active in all EUPHA activities, such as the EPH Conference and the European Public Health Week, but it also builds its own partnerships. In line with our commitment to involve the youth in a structural way, EUPHAnxt is represented at our Executive Council.

#### **EPH Conference Fellowship Programme**

6 students and young professionals are given the opportunity to participate at the conference by working alongside the EUPHAnxt and the EPH conference teams. They have mentoring sessions with public health experts, disseminate information about specific chosen topics through various communication platforms.

#### Mentoring programme

This programme was developed in 2022 and launched in 2023. It aims to link students and young professionals to mentors that are public health professionals. It is an opportunity for experts to share career advice and research-related activities, and for mentees to get to know the European Public Health field and its stakeholders.

This year, the programme listed 140 mentees and 36 mentors.


Section activity on X has been steadily growing over the years. In 2023, 18 sections were running an X account. All sections can be found on this  $\bigcap X$  list.
