Of the 10 members (inclusive of two advisors), 4 were present (SvdB, RR, EM, GB) and invited to stand and identify themselves to the other attendees.

Section administration

The structure of the new Section was explained, and the annual report was reviewed. In-progress items including developing a position statement. Attracting new members is a standing item. OO presented a walk-through of how to sign up to become a member on the EUPHA website, and shared the Twitter handle.

- <u>ACTION</u>: OO/CJ to set up a Bluesky account (upon receiving a system generated "invitation code") and migrate content and followers over to it when new account codes become available.
- <u>ACTION</u>: OO/CJ to schedule an online meeting of the Section in December/January. It was also discussed that the meeting could be organized after the Section Council meeting in February 2024.

Health literacy updates

OO presented the second edition of the IUHPE position paper on health literacy, additional resources, and a calendar of health literacy events.

Work plan 2024

A members' survey was launched by CJ. The survey will remain open until at least the end of the year and will inform the work plan. The survey is shareable via a link: https://lsbucomms.typeform.com/EUPHA-HL and QR code.

• ACTION: OO/CJ to share the survey in newsletters and on social media.

The survey asks the following:

- 3. How would members like to contribute?
- 4. How can member participation be enabled?
- 5. How can we support members to develop abstracts for EPHC 2024?
- 6. Any suggestions for topics to be considered for abstracts?
- 7. A call for ideas for European Public Health Week 2024.

Ahead of the survey results, current plans include:

- Collaborate on events for European Public Health Week
- Submit a pre-conference and workshops to EPHC 2024 in Lisbon, Portugal
- Engage in Health Literacy Month (October 2024)
- Engage in the IHLA Global Health Literacy Summit
- Record members' publications

Open discussion

CJ opened the floor for an interactive Q&A. Topics raised included:



- The term 'health literacy' in translation. There is an established term in Swedish. In other countries, e.g., Scotland, it may be called other things. Recommended reading: Sørensen, K. and Brand, H. (2014) Health literacy lost in translations? Introducing the European Health Literacy Glossary, Health Promotion International, 29 (4), pp. 634–644.

- Policy: related to the above point, it can be difficult to get health literacy on the policy agenda. Success can be due to a single champion (who may then move on). An overview of health literacy alliances by country would be helpful, perhaps including an update of country-specific chapters in: Okan, O., Bauer, U., Levin-Zamir, D., Pinheiro, P. and Sørensen, K. (2019) International handbook of health literacy: research, practice and policy across the lifespan.
