General communications with section members

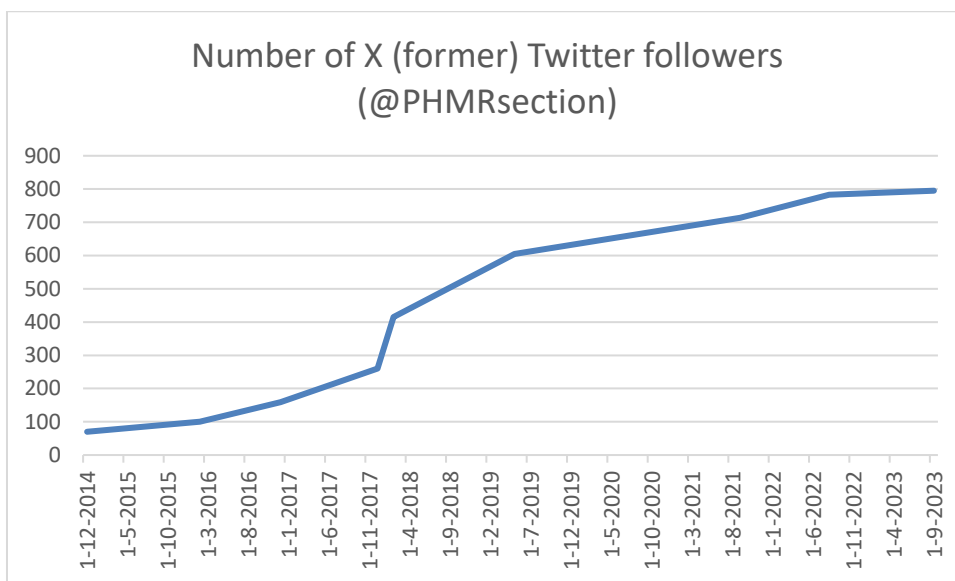
There has not been any general communication with section members.
