1. Publications, presentations and other activities by the section

The section President was asked to participate together with other EUPHA representatives in the external Evaluation of Joint Action on Health Information (InfAct).

2. Participation in the Steering Group of the WHO-EURO European Health Information Initiative (EHII) on behalf of EUPHA

The European Health Information Initiative (EHII) is a WHO Europe network committed to improving the information that underpins health policies in the European Region. It fosters international cooperation to support the exchange of expertise, build capacity and harmonize processes in data collection and reporting. The EHII is the umbrella network of several topic or region-specific networks:

- Central Asian Republics Information Network, CARINFONET
- European Burden of Disease Network, EBoDN;
- Small Countries' Health Information Network, SCHIN;

- a new health information network established within the South Eastern European Health Network, SEEHN
- a WHO Action Network on measuring population and organizational health literacy (M-POHL Network)
- European Evidence-informed Policy Network, EVIPNet
- Health information network with the Commonwealth of Independent States, CIS;
- European Health Research Network (EHRN)

By October 2018, the EHII had 39 members, including 30 WHO Europe Member States, several non-state actors, charitable foundations, and the European Commission and the OECD. When considering member state participation in health information networks, all 53 Member States of the WHO Europe Region take part in and contribute to at least one of these networks. In 2018, the EHII established a further sub-group on Evidence-informed Policy Making which met once following the Steering Group meeting.

The EHII works in six key areas:

- gathering and analysing information that deepens the understanding of health and well-being, with a focus on indicators;
- enhancing access to and dissemination of health information;
- building capacity;
- strengthening health information networks;
- supporting the development of health information strategies; and
- communication and advocacy.

The EUPHA PHMR section president participated in 2018 in one meeting of the EHII Steering Group.

The Steering Group meetings have usually a common structure:

- Updates from WHO Europe, especially regarding activities in the key areas and on the development of health information networks within the EHII.
- Updates from the EC, Eurostat and OECD as well as updates from the current major activities in Member States, including the EU health information Joint Action InfAct and their work on the development of a European Research Infrastructure Consortium on Health Information for Research and Evidence-based Policy.
- Updates on activities like a health indicator mapping exercise. This exercise aims to
 identify overlaps between indicator sets of the main international health information
 stakeholder in Europe (WHO-Europe, OECD, Eurostat). Updates on the revision of
 the SUPPORT tool, a tool that is used to assess health information systems and
 develop national health information strategies.
- Review of the action plan and suggestion of new actions.

During the meetings the EUPHA PHMR president has given updates on EUPHA activities like publications and EPHC pre-conferences and workshops.
