1. Facts and figures about the section

- ⇒ established in 2011
- ⇒ 1927 section members
- ⇒ ...so far 7 EUPHA PHMR newsletters with information from international/European organisations, projects, initiatives, PHMR information from section members, section news and information on activities at the EPHC.
- ⇒ 540 follower on Twitter, about 1200 tweets since 2012
- ⇒ The section is involved in the WHO European Health Information Initiative and in the External Evaluation of [InfAct](#) (a European Joint Action on Health Information)
- ⇒ Broad spectrum of topics covered in EPHC workshops and pre-conferences: Data visualisation (websites and dashboards), international health information systems and data bases, infographics, PHMR and place, participatory approaches, tools for knowledge translation, innovations in health reporting, strengthening health information systems, migrant health, LGBTQ, upstream determinants.

2. EUPHA PHMR elections

- ⇒ Election of EUPHA PHMR president and vice-president positions in 2020.
- ⇒ Procedure: Call in April 2020 (interested persons are asked to submit a motivation letter and a CV), EUPHA PHMR Steering Group pre-selects suitable candidates, EUPHA office checks membership status, voting by section members.
- ⇒ Some participants already signalled interest in the position during the meeting.

3. EUPHA PHMR goals and activities for 2020

- ⇒ The section is interested to organise an EJPH e-collection on PHMR. The section president will contact the EUPHA office for more information.

⇒ The section is interested in doing a PHMR section survey.

Aim: To gain better knowledge about the section members.

- area of work, research versus public authority;
- roles in PHMR processes
- planned innovations in PHMR
- topics the section should deal with (also during future EPH conferences)

Ideally the section can find an interested Public Health student who can support the section in this (e.g. linked to a Bachelor thesis). The section president will contact some universities for this. Additionally, EUPHA office is contacted to identify possibilities for online surveys.

⇒ The section is planning to update the section website.
