1. Section in brief

The EUPHA section on Chronic Diseases (EUPHA_CHR) was formally established at the 14th EUPHA annual conference in Montreux, Switzerland in 2006 and currently lists 2,173 members.

The aim of the section is to increase and spread knowledge on chronic disease control and management. The section seeks to identify common approaches to develop the evidence and information base needed to guide policy and identify best practices for combating chronic diseases, and thus contributing to a sustainable and significant reduction of illness, disability and premature death. Furthermore, the section aims to lead efforts that help eliminate health disparities and negative socioeconomic consequences caused by chronic diseases and that promote health and well-being. Title	3.G Workshop: Impact of nutrition on non-communicable chronic diseases: a global perspective
Date and place	Thursday 21 Nov 14:50-16:20, Room Endoume 4
Organizers	EUPHA sections: Food and Nutrition (FN); Chronic Diseases (CHR)
Aims	The objectives of the workshop were: To quantify the burden and temporal trends of non-communicable chronic diseases risk factors (such as obesity, elevated blood pressure and diabetes) all around the globe, with a focus on European countries; To assess the impact of nutrition-related risk factors on non-communicable chronic diseases; To explore socio-economic and cultural correlates to dietary changes in developed and developing countries; To discuss the usage of instruments aimed to identify best practices in food policies to prevent junk food consumption.
Participants	Approximately 67 participants attended the workshop.

	order to improve their capacities for the adoption and scaling-up of integrated
	care. The workshop also aimed to raise awareness about different levels and
	mechanisms of capacity-building support for integrated care that exists at
	European level. In particular, the workshop featured SCIROCCO Exchange
	Knowledge Management Hub as one of the capacity-building tools and its
	application in the real-life settings.

It also sought to provide public health and healthcare professionals with both theory regarding effective KT skills and best practice examples enhancing knowledge translation.

4rd V4 Conference on Public Health, 25-26 April 2019, Debrecen, Hungary

The V4 countries - Czech Republic, Hungary, Slovakia and Poland - have common history, common challenges, common public health problems and we have to find common solutions together. Prof Roza Adany, president of the Hungarian Public Health Association, was the main organiser of the 4th V4 Public Health Conference in Debrecen in collaboration with national public health associations of V4 counties. Dr Dineke Zeegers Paget, EUPHA Executive Director and Prof. Martin McKee EUPHA, Immediate Past President, joined the conference as well discussing the current public health challenges. Dr. Iveta Nagyovas in her speech "Knowledge to Action? Evidence-Informed Public Health" shared her vision on knowledge translation challenges in V4 countries.

CHRODIS PLUS General Assembly; 14-15 May 2019, Budapest, Hungary

Dr Iveta Nagyova was invited to have Closing words on behalf of the EUPHA at the CHRODIS PLUS General Assembly meeting. CHRODIS PLUS is a high level response by the EU to support member states by stepping up together and sharing best practices to alleviate the burden of chronic diseases. This three-year initiative (2017-2020) under the third health programme (2014-2020) is funded by the European Commission and the participating partner organisations. In CHRODIS PLUS, 42 partners, representing 21 European countries, collaborate to implement pilot projects and generate practical lessons in the field of chronic diseases. Dr. Nagyova's keynote lecture dealt with "Tackling chronic diseases in migrants and refugees: Bridging the evidence policy gap". Apart from I. Nagyova also Alan Krasnik and Maria Luisa Vázquez from the EUPHA section on Migrant and Ethnic Minority Health represented EUPHA at the conference.

6. Collaboration

EUPHA_CHR's strategy is to promote collaboration and strategic partnerships with stakeholders in the field of chronic diseases. With regard to EUPHA sections, in 2019 we co-organized a workshops in collaboration with the EUPHA section on Food and nutrition. To our main strategic non-EUPHA collaborating partners belongs the WHO/Europe, especially its two divisions: Division on Noncommunicable Diseases and Life Course; so far we organized together 5 workshops at the European Public Health Conferences (2011, 2012, 2014, 2016 and 2017); and the Division of Information, Evidence, Research and Innovation (so far 3 joint workshops were organized: 2017 and 2018, 2019). A new experience has been a collaboration with the IBTN – International Behavioural Trials Network on a workshop dealing with behaviour change and knowledge translation. Another group of collaborating partners include the Scottish Government and consortium of a EU-funded project SCIROCCO Exchange.

EUPHA_CHR has a special focus on future public health professionals via its collaboration with EUPHAnxt, which is a free and open initiative that aims to collect the active contribution of students, young researchers, practitioners, and policymakers interested in European public health issues, in order to sensitize and involve them into the European and multidisciplinary network of public health associations. In 2019 EUPHA_CHR contributed together with the EUPHAnxt to the Abstract Mentor Programme, which provides an opportunity for young and/or less experienced abstract submitters to receive feedback from experts before submitting their abstract for EPH conference.

7. Communication

Following the completion of the mandate by the EUPHA_CHR president Dr Iveta Nagyova the EUPHA section on Chronic Diseases announced the start of the election procedure for new section president on 28th August 2019 with detailed description of requirements as well as future responsibilities (deadline 9th October 2019). The section president's tasks include supervising the section's affairs, reviews existing activities, monitoring scientific and policy developments in the field and contributing to EUPHA advocacy, education, and research activities. During the JTN meeting at the 12th EPH conference in Marseille the candidate for presidency - Prof. Julian Mamo, Head of Department of Public Health, University of Malta and Mater Dei Hospital, Malta - was officially elected as new section president for the period of next 3 years. The new vice-president became Prof. Saverio Stranges from Western University Department of Epidemiology and Biostatistics, London, Ontario, Canada.
