Goals for 2022/23

 competence and resilience of public health workforce / education and
 training in public health ethics.
 - ii. Delivery of webinars and workshops
 - iii. Take forward recommendations of the report on variability in education and training in public health ethics
 - b. Development of Code of conduct and professional ethical public health practice
 - c. Promote moral courage and resilience in public health workforce
 - d. Take forward recommendations and issues raised in the report on moral distress and injury in public health workforce
 - e. Advance the work on public health values and implications for policy and practice
- 2. Continued collaboration with other EUPHA sections, FPH, ASPHER and other partners to advance the discourse, scholarship and practice in public health ethics
- 3. An increased visibility and participation in the 2023 EUPHA conference and World Congress of Public Health and other fora.
- 4. Continue to collaborate and support other EUPHA sections and other stakeholders to support their consideration of ethical issues in their activities

Achievements in 2021/22

- 1. The section has been active in a variety of activities related to the COVID-19 pandemic:
 - The president of the section was invited to the Royal College of Physicians of Edinburgh symposium on Wednesday 14 April 2021: *The Public's Health after*



Covid: science and social justice. The title of the contribution was: Covid-19: opportunities for public health ethics?

Subsequently an article was published: Maeckelberghe, E. L. M. (2021) COVID-19: opportunities for public health ethics? *Journal of the Royal College of Physicians of Edinburgh*. doi: 10.4997/JRCPE.2021.241

- The section was also represented in the COVID-19 Response and Preparedness and Response Series Webinar 1: TRIPS
 This was the first webinar organised by the European Public Health Association (EUPHA) in collaboration with the French Public Health Association (Société Française de Santé Publique) (SFSP), and with the support of EUPHA's Health Technology Assessment Section (EUPHA HTA), a series of events to raise awareness and to share the knowledge of experts on key aspects regarding: COVID-19 Preparedness and Response. The section's contribution was a talk about by its president: TRIPS Waiver, Knowledge Transfer and Vaccine Distribution Ethical reflection. - The section collaborated with Faculty of Public Health, ASPHER and others in development of ethical dimensions of various policies and statements related to the Covid Pandemic. This has included input to various working groups and production of variety of statements, guidelines and resources.

The "EUPHA Ethics in Public Health Section" has continued to collaborate with the UK Faculty of public health, ASPHER, law and public health section and other partners around a range of activities, for example:

- The Faculty of Public Health in collaboration with EUPHA ethics in public health and the
 public health and law sections, and other partners have been organising international
 webinar series on public health ethics, law and human rights for the future of
 humanity. There has been wide interest and support for the webinars with over 900
 people registering for the first webinar and over 500 for all the subsequent webinars.

- The Faculty working in collaboration with the "EUPHA Ethics in Public Health Section" and various ethico-legal academics, practitioners and researchers on education and training in public health ethics have highlighted the importance and relevance of the issue and that there is continuing demand and need to develop and support wider public health ethics and law (PHEL) capacity among the public health health workforce through the provision of PHEL education, training, guidance, and mentoring.

In light of the evidence the "EUPHA Ethics in Public Health Section" in collaboration with FPH have been working to devise various strategies to address the issue:

- The Faculty in collaboration with ASPHER and EUPHA carried out survey of schools of public health and public health workforce in Europe and has established a joint working group on public health ethics and law.
 - It has published a report on Variability in education and training in public health ethics in Europe

 - develop a joint high level policy paper on education and training in public health ethics and law
 - consider implications for public health curricula and develop a competency framework in public health ethics and law
- Code of ethics and professional conduct for public health The WHO /ASPHER European competencies framework for public health workforce highlighted public health ethics and law as a core issue. Scotland has been highlighted as a pilot site to explore development of code of professional conduct and ethical practice. "EUPHA Ethics in Public Health Section" has been working with FPH and the Scottish public health ethics forum, consulting on the issue at its various public health ethics forum gatherings prior to the pandemic. There are plans to re-establish a working group to take forward the issue in 2022.
- The Faculty ethics committee is collaborating with researchers at LSE and University of Durham in a project on 'Paternalism, Health, and Public Policy' funded by the Wellcome Trust. There was a two day on-line workshop on 'Paternalism and Public Health' held on 14th and 15th September 2021, including a round table on the Faculty report on 'The Nanny State Debate. https://paternalismhealthpublicpolicy.org/workshop-1-paternalism-and-public-health/



- 2. Accepted Section Submission for EPH conference 2022 have included:
- Round table: Is public health just science?
- Workshop: Commercial determinants and global capture of public health- cases spanning the world
- Workshop: Quality of COVID-19 science: meta-research and the ethical implications for public health
- The section continues to be concerned that there appears to be preference and focus on epidemiological and statistical based submissions and the need to also properly consider humanities and social sciences and ethical and legal submissions.

Collaboration with section members

Section members were encouraged to collaborate submitting proposals for the EPH2022 conference and to communicate with help of the section among each other to initiate projects on public health ethics.

The section has a steering committee/core group who meets regularly.

The section ha collaborated and supported initiatives and activities around public health ethics in various countries

Activities at the EPH Conference 2021

In a collaborative effort with section members and partners, several proposals for workshops were submitted and have been accepted:

- Round table: COVID-19, ethics, and the many publics in public health policy and practice
- Workshop: Intersex human rights and wellbeing
- Workshop: Integrating the use of genomic data in personalised healthcare: implications across the board
- Workshop: Intersex human rights and wellbeing
- Workshop: Moral distress and moral injury in the public health community in times of COVID-19
- Round table: The Aftermath of COVID-19
- Workshop: The contribution of Environmental Impact Assessments to better health
- Round table: COVID-19 Digital Green Certificate: Hope for restoring freedom or simply opening Pandora's box?

Other activities

The collaboration with the UK Public Health Faculty remains important for EUPHA-ETH. The vice-president, Farhang Tahzib ensures the continuity of this collaboration.



Some activities during the past year have included:

- UK FPH in collaboration with Ethics in Public Health Section and ASPHER carried out a survey of public health workforce and schools of public health in Europe.
 Due to be published September 2022.
- UK FPH and EUPHA ETH and Law and public health sections organized international webinar series on "Public Health Ethics, Law and Human rights for the future of humanity" covering various themes and issues. There has been widespread interest in the various webinars with over 900 people registering for the first webinar. The section is collaborating with the UK FPH and ASPHER in development of Code of professional conduct and ethical practice in Scotland and other pilot sites.
- The section is collaborating with the UK FPH in supporting educational and training initiatives in public health ethics and supporting young public health professionals

- Public health ethics education is a poorly defined field
- There is lack of expertise and support
- Public health professionals perceive they have a good understanding of, and response to ethical dilemmas in their professional lives



Variability in education and training in public health ethics in Europe




Situations in which moral distress

- Developing/implementing national policy, guidance and law.
 Giving public health advice.
 Workplace relationships and environments.

Moral judgement that led to

- Causing injury to others.
 a) Pursuit of public health goals at the expense of other goods.
 - b) Doing harm through blind obedience to guidance. Inaction/inability to do good.
- (Dis)honesty in public health
- Unjust prioritisation decisions.
 a) Advising without sufficient resources.



- Better decision making.

 a) Better national policy and guidance.
 b) Decentralisation of decision making.
 c) Flexibility in national guidance
 Communication and participation.
 Practitioner moral development & support.
