### **Organizers**

The World Health Organization (WHO) Regional Office for Europe, Health Services Research (HSR) Europe, the EUPHA Section on Public Health Practice and Policy and the EUPHA Section on HSR.

#### **Aim**

To share knowledge and experience, and to openly debate on how to promote evidence-informed decision-making (EIP) in the European Region.

#### **Background**

Regardless of our positions in the health care field, we all recognise that health research does not automatically feed into policy and decision-making, thus limiting the possibilities of making use of scientific evidence and best practices. Past European Public Health conferences have extensively addressed factors which hamper the uptake of research evidence. Our ambition is to take these discussions a step further and identify how we can jointly create an environment favourable to research utilisation, among others by addressing growing evidence on strategies and infrastructures leading to a co-production of policy-relevant research and evidence-informed policies.

As requested by its Member States, the WHO Regional Office for Europe recently developed, in consultation with researchers and policy-makers, an accelerated roadmap to enhance evidence-informed policy-making (EIP) in the European region. This roadmap calls for joint actions of all stakeholders with a vested interest in strengthening EIP. As a starting point for discussions, the preconference will provide a forum to present the WHO Regional Office for Europe accelerated roadmap for key stakeholders to *reflect on this roadmap* and to share their knowledge and experience on what has and has not worked in the past. It also provides room to *openly debate what each can contribute to* EIP, individually and collectively, both at national, European and sectoral/organizational level, e.g. within hospital settings, for health insurance companies, patient organizations, etc.

### **Target audiences**

Stakeholders of all levels in the health services and public health research community, established experts on EIP and knowledge translation (KT), knowledge brokering organizations, policy-makers, managers and other decision-makers in health care, and other stakeholders and NGOs at national and European level.
