EUPHA section on Health Workforce Research (EUPHA-HWR)

Goals for 2023

The future goals build on our previous activities and seek to provide a forum for academic and policy debate, build capacity for health workforce research and strengthen the voice of the health workforce researchers in health systems and policy development. More specifically, the 2023 goals include:

- strengthen the efforts to learn from COVID-19; improve resilience and preparedness of the health workforce (see EJPH, Supplement, November 2021);
- support EUPHA activities;
- take action to expand the membership of the EUPHA section HWR;
- strengthen collaboration with our partner associations/organisations and other stakeholders in the field of healthcare workforce research and explore further opportunities for collaboration with other EUPHA sections and groups;
- highlight the global dimensions of health workforce research and strengthen solidarity across countries, regions and professional groups;
- improve attention to the needs of individual HCWs beyond health labour markets the "human face" of the health workforce (see EJPH, 2020) and strengthen mental health and wellbeing of HCWs to prevent reduce stress and burn-out;
- improve inclusion/participation, gender equality and ethnic diversity of the health workforce;
- initiate a debate into 'violence against healthcare workers' to raise awareness, improve
 protection and advocate for a zero tolerance policy against all forms of discrimination
 and violence of HCWs, including sexual violence;
- support activities against gender-based and sexual violence in the health workforce;
- initiate a debate into 'circular migration' and highlight the need for European regulation
 of the health workforce based on solidarity and fairness, including the public health
 workforce;
- contribute to the EPH Conference in Dublin 2023 and proceed with mid-term activities (e.g. webinars and workshops/presentations at WHO and other meetings of partner organisations) to strengthen advocacy for health workforce research and the EUPHA-HWR section.

Collaboration with section members

The EUPHA-HWR section is based on a collaborative network of individuals and partner organisations/associations. The latter ones include, in particular, WHO Regional Office for Europe, the European Observatory on Health Systems and Policies, EHMA/European Health Management Association and ASPHER, as well as contacts with professional associations, like CPME/Standing Committee of European Doctors. Knowledge exchange has also been



established or is planned for 2023 with a number of other colleagues and groups, e.g. Africa-Europe Foundation.

Within EUPHA, collaboration has been established with EUPHAnxt through collaboration with Monica Brinzac (EUPHAnxt Coordinator), with EUPHA-ENV (Marija Jevtic) and with EUPHA SDG5 Working Group (Elena Petelos) and EUPHA-HIA and will also be established with EUPHA-PHHP.

Activities at the EPH conference 2022

Spring webinar series March-May 2022

Organisation of a spring webinar series March-May 2022, comprising four webinars. One important aim of this webinar series was to strengthen and/or establish new collaborations and to make connections between the different areas and actors in health workforce research. The webinars attracted between 35 and 55 participants from a broad range of actors in health workforce research, practice and policy.

- The health workforce: in need of a "booster" for mental health protection and violence prevention, hosted by CPME (Sarada Das), attracted more than 50 participants, including representatives from the Commision and several EU organisations and professional associations/networks.
- Healthcare workers walking the trans-sectoral health and social care walk: how to improve integration?, hosted by Babeş-Bolyai University, Romania (Marius Ungureanu).
- Building capacity for environmental health and climate action: engaging healthcare workers, hosted by EHMA (George Valiotis), in collaboration with EUPHA-ENV.



The contribution of health labour market to health workforce policy development, WHO-HQ and EUPHA-HWR, hosted by WHO-HQ and EUPHA-HWR Vice-president Gilles Dussault, presentations from Pascal Zurn (WHO HQ), Gaetan Lafortune (OECD) and Tomas Zapata (WHO Europe).

Other activities

Development of new collaborative project on 'Violence against healthcare workers as a public health crisis', involving EUPHA-HWR and members of EHMA, EUPHAnxt, European Observatory on Health Systems and Policies, and WHO Euro. It is planned to continue and strengthen the work on violence against HCWs in 2023, e.g. contribute to the awareness Day on 12 March 2023; submit a workshop for EPH Dublin; build collaborations with national professional associations.

A further important topic for 2023 is 'Circular migration' of HCWs. In collaboration with WHO Europe and others a workshop proposal has been submitted to the Global Forum on Human Resources for Health, April 2023, Geneva.
