Third Meeting of the Coalition of Partners (CoP) to strengthen public health capacities and services in the European Region, 27–28 November 2018, Cankarjev dom, Ljubljana, Slovenia

The Coalition of Partners (CoP) project, led by WHO Europe, was held in Ljubljana prior to the EUPHA Conference and co-hosted by the Ministry of Health of Slovenia and WHO/Europe's public health services programme. The Coalition of Partners (CoP) is an international network that brings together experts and practitioners from within national public health services, international organizations, civil society and academia. The goal is to strengthen services catalyse action to public health at the national http://www.euro.who.int/en/health-topics/Health-systems/public-health-services/coalition-ofpartners. EUPHA presented their approach 'A proactive and prosilient approach to public health' to the participants. Health workforce issues were among the key themes during the meeting, and HWR participated as EUPHA delegate (thanks to the Office for the support!). For instance, a lunch time session related to the public health workforce was organised by the ASPHER President and EUPHA HWR. Overall, the WHO/ CoP project was perceived as very useful and a success, and the team will continue the work; see the website for updates.



The next EHMA Conference is scheduled for 17-19 June 2019 in Espoo, Finland. Health workforce issues will again be present at the Conference and addressed in the sessions. The Call for Abstracts for the is open now, **deadline 17 February 2019**. Abstracts can be

submitted to 6 different 'sub-themes' of which theme 1 "Systems & Organizational governance" probably best fits health workforce issues. This sub-theme is described as: "presentations related to systems and organisational governance at European, national, regional and local levels. A particular area of interest is the skills and competencies required to deliver effective governance and the means by which health system governance can be established. Questions to focus on: How can we make this shift towards Health Management 2.0 happen together, how do we deliver it? What new styles of leadership, partnership, skills & competences are needed?
