# Report 2018 of the Presidency of the EUPHA Section Infectious Disease Control

#### **EUPHA-Infectious Disease Control**

The section Infectious Disease Control (IDC) of the EUPHA was founded in 2002 in Italy and has by now 1280 members throughout Europe and the world. The unique selling point of the EUPHA section IDC is that it offers a platform for research, policy and practice, bringing together people from various domains of expertise in order to frame the public health relevance of IDC.

#### Goals

We aim to build up a strong organization in which as many as possible members are actively involved. Furthermore, we aim to reach out to other sections within EUPHA, and European organizations (such as the ECDC and WHO-Euro) preferably by organising joint workshops/pre-conferences during the future European Public Health Conferences. We aim to disseminate the knowledge generated by these joint sessions to a larger public health audience by regular publications in international journals. We want to strengthen the communication within our organisation through the LinkedIn page and through our regular newsletter. The section web page is being permanently monitored.

### **EUPHA-IDC** core group in 2018

# Preview EUPHA-IDC at the European Public Health Conference 2018, Ljubljana

The 2018 European Public Health (EPH) Conference is themed: 'Winds of change: towards new ways of improving public health in Europe' and will be held between 28 November and 1 December in Ljubljana, Slovenia. There will be again a full track on infectious disease control /preparedness and vaccination. Among others, there will be workshops, oral sessions, pitch presentation sessions and posters walks on 'Vaccination service, delivery and response', 'Vaccine compliance and hesitation', 'Sexually Transmitted Infections Among Men Who Have Sex with Men Across Europe', 'Vaccination in school children in Europe: when and how?' 'Infectious diseases: outbreak, prevention and vaccination', 'Infectious diseases: screening and impacts', 'Linking outbreak preparedness and response: bridging the gap'. A representative of the section will take place in the EUPHA webinar on AMR. Noteworthy, this year we have been successful

in linking to other EUPHA sections and organize joint activities (such as with the sections on Child and Adolescent Public Health and Sexual and Gender Minority Health).

#### Representation on behalf of the EUPHA

In September 2013, Aura Timen became a member of the Advisory Forum of the ECDC on behalf of the EUPHA and thus participated in all meetings of the AF. After completing a mandate in April 2018, she has been nominated again for a new mandate by the European Commission in June 2018.
