Publications: Contributed to the Editorial for the EUPHA e-collection, by the Czech Society of Social Medicine and Health Care Management, to support the Czech EU Presidency. It aimed at presenting the evidence base for managing the refugee crisis and post-war Ukraine. The Czech society decided to focus it on the question: What is useful for us to know for caring for refugees from Ukraine?

EUPHA- MIG THEMATIC PROPOSAL – DisQo - anti-discrimination & health equity" with the EPH Alliance on Equity. In close collaboration with EUPHA Brussels office and other partners the section developed a proposal for a thematic network with the Health Policy Platform of the European Commission. to discuss and brainstorm ideas (how to organize the meetings with the network, how to approach the further building of it, drafting a strategy for the webinar series, and of course the Joint Statement development), which we can then bring to the bigger network for a wider discussion

### **COLLABORATION**

The Section continues the strong collaboration with GSMERH, WHO, EU, ECDC and Lancet Migration among others. This includes participation in various initiatives, meetings and projects. Highlights are given below

Collaboration WHO Europe: The section has participated in the expert group preparing for the High-level meeting, participated in the High-Level meeting in Istanbul March 2022 to discuss the Strategy on Migrants and Refugees in May 2022.



Collaboration WHO Programme on Migration and Health (Global): Contributed to the launch event of WHO Global Evidence Review on Health and Migration (GEHM) on Continuum of Care for Noncommunicable Disease Management during Migration Cycles. Reviewer and Contributed to the Global launch of the WHO World report on the health of refugees and migrants Health and Migration Programme (PHM) for participating in the first online technical consultation on the Global Research Agenda for Health and Migration that took place on September 26th 2022

Collaboration Global Society on Migration, Ethnicity, Race and Health. The work of the interim committee with strong support of EUPHA MEMH SECTION and EUPHA Secretariat continues with the establishment of the Society as an organization registered as a charity in Scotland and planning for the 2024 World Conference.

# Participation of Section in International Conferences/Events

The Presidency of the Section continues to present issues of migrant and ethnic minority health at international and national meetings and to review and contribute to European publications on migrant and ethnic minority health.

Steering Committee Meeting: As the EUPHA conferences have been virtual it was deemed essential to have an additional meeting to discuss strategy, plans and activities. It was decided to meet more often. Changes are required in terms of organization and structure. These have been initiated
