# **Meeting minutes**

# Opening

Prof. Dr. Jutta Lindert opened the meeting and gave her thanks to the attendees for participating in the online conference.

#### Introduction

Every attendee shortly introduced themselves and stated their profession and research field of interest.

#### Presentation

Jutta Lindert gave an overview of the section activities in 2019 and 2020. She shared a presentation which included a description of two studies, COPEERS and COCARE, she is currently working on together with members of the PMH section. Both studies investigate mental health during the SARS-CoV-2 pandemic. She encouraged the attendees to participate in these studies if interested. Interested persons should contact Jutta to evaluate cooperation possibilities.

Serving the EUPHA Public Mental Health Section

Proposals on how to serve the Public Mental Health Section committee were presented.

Possible duties are e.g. social media activities, preparing summer school or do a podcast or webinar about suitable themes, or as member of the Steering Committee, or as vice-president.

## Steering Committee

The requirements for serving as steering committee members were proposed. Its members should be balanced in gender and cover different disciplines and different countries.

Additionally, members should have participated in the EUPHA (European Public Health Association) conference (at least three times in the past five years) and in Public Mental Health section activities (at least in three annual meetings). They should actively have participated in the Public Mental Health -workshops (submitted at least one paper).

#### Vice Presidents

The requirements for serving as vice-presidents were proposed. Vice-presidents should be balanced in gender and cover different disciplines and different countries. Vice —presidents should be experienced in participating in the EUPHA (European Public Health Association) conferences (at least three times during the past five years) and in public Mental Health section activities (at least four times). They should have participated actively in PMH-workshops (submitted at least one workshop in cooperation with the PMH-Section president / vice-presidents).

Additionally, the vice-presidents - in close cooperation with the PMH section president - should have served in preparing the PMH Summer School and the PMH bi-annual conference.

#### Outlook 2021

Plans for 2021 include planning of workshops and contrive the Summer School, as well as the annual meeting. Due to the actuality of the topic, papers about Public Mental Health and its relation to the SARS-CoV-2 pandemic are planned. People interested to contribute should contact Jutta.

# Leadership of the EUPHA PMH section

Prof. Dr. Lindert explained that she will step down as president of the Public Mental Health Section by the end of the year. Dr. Marija Jakubauskiene has been elected as new president for the PMH section. Johan Bilsen and Jutta Lindert will serve as vice-presidents. Prof. Mauro Carta, Dr. Johan Cacchia and Silvia Fiorescu will serve in the Steering Committee.

# Future project suggestions for the EUPHA PMH section

The attendees had various suggestions for future projects/themes for workshops
The following topics were proposed:

- Mental health and social media (internet addiction, self-harm, ...)
- Mental health and the criminal justice system
- Mental health and behavioral dependencies (e.g. addictions, substance dependencies,...)
- PTSD (Posttraumatic Stress Disorder) and dependencies (especially in immigrants, ethnic minorities and refugees)
- Mental health and transdisciplinary approaches (social and environmental determinants, living conditions)
- Multimorbidity in relation to mental disorders
- Mental health and urban planning / architecture (healing spaces, ...)
- Public mental health: impact of neurosciences

Especially the interdisciplinary approach regarding mental health was met with approval. It was suggested as a possible leading theme for Summer School 2021. The possibility of inviting e.g. a philosopher as well as a neuroscientist would lead to an open and broad discussion on mental health issues.
