EDITORIAL 2024 - A year of transformation

As we reflect on the past year, 2024 marks a defining moment for EUPHA - a year of renewal for leadership, team, and strategic transformation. A strategy for the future

Our strategy is grounded in four core principles, the 4 E's: Evidence, Equity, Empowerment, and Engagement. These guide everything we do, from policy influence to capacity building.

We have intensified our advocacy efforts, expanded our partnerships, and deepened engagement with policymakers, practitioners, and civil society. A significant milestone has been our strategic decision to establish our **Head of Advocacy and Policy** in Brussels, positioning us to better influence European institutions and strengthen our presence in critical policy discussions.

To support the implementation of our strategy, we have also strengthened our internal team. A new **Scientific & Project Manager** is now leading efforts to consolidate knowledge, steer innovation and maintain EUPHA's relevant role within several EU projects. We have appointed a **Network Coordinator** to enhance the connection between our members and sections, empowering them to have a stronger impact on the ground, where public health truly happens. To ensure transparency, good governance, and sound financial management, we have also recruited a new **Chief Financial Officer (CFO)**. In parallel, a new **Communications Manager** has joined the team, helping amplify EUPHA's voice and support effective outreach.

President's Priorities

From one president to another, this year also marks a symbolic transition in leadership. Iveta Nagyova concluded her mandate in November 2024, having led EUPHA through turbulent times—including the COVID-19 pandemic and an internal transition in management. She leaves behind a stronger, more resilient organisation, directed toward innovation and future-readiness. As she now assumes the role of Chair of the European Public Health Conference, we are confident that EPH will continue to evolve in new and exciting ways under her guidance.

Our new president, Tit Albreht, has set an ambitious line for his mandate, focusing on three key priorities:

- ★ **Confronting emerging challenges:** Taking decisive action to address the threats of health misinformation, conspiracy theories, and commercial determinants of health that undermine progress across Europe.
- ★ Empowering youth leadership: Following EUPAnxt Coordinator's recommendations, we are committed to elevating young professionals, ensuring that fresh perspectives drive innovation in our field. We are proud to welcome new co-chairs of EUPHAnxt, who will continue to bring youthful leadership and creativity to the heart of our work.
- ★ Expanding our reach eastward: With a focus on Eastern Europe, the Caucasus, Ukraine, and Moldova, we are building strategic synergies with WHO and partners to support these regions through expertise, resources, and networks.

2024: a year of renewal

New strategy

We were very pleased to introduce the EUPHA 2025-2030 strategy focused on the "4E":



- **1. Evidence:** Support and disseminate high-quality research to inform public health policies.
- **2. Empowerment:** Build capacity among public health professionals and communities.
- **3. Equity:** Champion inclusiveness and reduce health inequalities, especially among underserved populations.
- 4. Engagement: Foster cross-sector collaboration for communitydriven health initiatives.

During the whole year, we have been leveraging a bottom-up approach to co-create our strategy with members and sections. We ensured our initiatives are responsive to emerging signals and aligned with the missions and values of the public health community. Our principles and methods are grounded in collaborative, evidence-based, and inclusive practices that foster sustainable health improvements across Europe.

A large survey gathered feedback from our members and sections to identify their key priorities, visions, and needs. We then organised an online workshop to analyse the survey responses and discuss their vision of EUPHA and their expectations. In June 2024, we held a Strategy Retreat with our Executive Council and inspiring figures in the field to foster reflection and strategic planning for the forthcoming five years.

The EUPHA Governing Board eventually approved the new strategy in November 2024, during the EPH Conference.

Our mission is to bridge science and policy, empowering public health actors to advance evidencebased solutions that improve health for all.

EUPHA new strategy 2025-2030

A change in presidency EUPHA has undergone a significant leadership transition as we bid farewell to Iveta Nagyova, who served as President from 2020 to 2024. During her tenure, she guided EUPHA through the challenges of the COVID-19 pandemic and key transitions within the EUPHA office, ensuring the organization emerged stronger and poised for continued growth. Her unwavering dedication and vision have left a lasting impact, and as she steps into her new role as Chair of the EPH Conference Foundation, we extend our deepest gratitude for her remarkable contributions.

EUPHA's Executive bodies

Executive Council: Charged with the management of the association, composed of prominent public health experts in Europe, including the EUPHA president, past president, president-elect, treasurer, secretary, EJPH editor-in-chief, Section Council chair, and EUPHAnxt coordinator an special adviser. Governing Board, representing the Members: The highest authoritative body in EUPHA, comprising delegates appointed by the members of each country. Institutional members have a non-voting seat. EJPH Council: Coordinates the general policy for the European Journal of Public Health (EJPH) and EUPHA's activities related to the Journal.

Section Council: Represents the interests and common concerns of all EUPHA sections, facilitates relations between sections and other relevant bodies, and makes recommendations to the annual European Public Health conference programme.

EUPHAnxt Team: The EUPHAnxt team supports the activities of EUPHA. EUPHAnxt is EUPHA's network for students and early career researchers, policymakers and professionals in the field of public health. It gathers around 4000 professionals across Europe.



EUPHA's Office

The EUPHA office is responsible for the day-to-day running of EUPHA. The EUPHA office has weekly meetings to discuss all issues of the work plan, to execute the concrete operational framework and for upcoming questions and new initiatives. Related to the activities included in the operating grant, the EUPHA office team consists of the Executive director, the Chief Finance and Administration officer, the Communication Manager, the Network Coordinator, the Policy officer and the Office manager.

ACTIVITIES



Sections

To facilitate building and disseminating evidence throughout Europe, EUPHA hosts, approves, and coordinates themed networks, called EUPHA sections, for specific public health themes. These sections are international and open to all public health experts, bringing together researchers, policymakers, and practitioners for evidence generation, knowledge sharing, and capacity building. IEUPHA has 29 operational sections on a wide range of public health topics (see table in <u>Annex 2</u>), supported financially and organisationally by the EUPHA office. The presidents of the sections are renowned experts in their fields, supported in subject expertise by vice-presidents and steering groups.

Section Council

In February, the Section Council was held in Utrecht between the sections' presidents and the EUPHA Office. It was the opportunity to open the discussions through a World Café and develop a plan of implementation to reinforce the Governance, the Communication, and the sections' involvement during the EPH Conference.

In September, another Section Council was organised online. Follow-ups on the workshops organized after the February session were first presented. The sections then shared their latest news, and discussed potential themes for the next European Public Health Week (EUPHW).

Sections Activities (detailed in Annex 2)

All EUPHA sections were very active throughout the year, sending a total of 76 newsletters to their subscribers, organising 21 webinars (detailed <u>below</u>) and coordinating 5 events to the EUPHW.



They were also present during the 17th EPH Conference with a total of 11 pre-conferences, 17 round tables, 8 skills building seminars, 33 Scientific session, 2 practice sessions and 30 'join the network'-meetings.

EUPHAnxt

Fellowship

programme

The EPH Conference Fellowship Programme – launched in 2018 by EUPHA and EUPHAnxt – offers students and young professionals an opportunity to participate at the conference with an active role. In 2024, EUPHAnxt received 49 applications from students, young, and early career professionals from Europe and abroad. Six selected fellows are given the opportunity to work alongside the EUPHAnxt and the EPH conference teams to disseminate information about the conference through various communication platforms. The fellows also get the chance to have mentoring sessions with senior public health experts. The role of the selected fellows is to follow all sessions on a specific topic of their interest and report on these sessions in the form of short interviews with the speakers. Furthermore, the fellows contribute to the daily podcast named YUPT (Yesterday's Update, Plans for Tomorrow). This YUPT is made available every morning at the start of the conference day.



Abstract

tutoring

programme

Young health researchers could submit their abstract to receive advice for improvement before officially submitting it. In total, 21 abstracts were reviewed by 15 reviewers (Dublin 2023: 25 abstracts. by 16 reviewers). Of this year's 21 abstracts, 15 were finally submitted and 10 were accepted (67%). Last year, the success rate was much higher than last year (90%) with 20 abstracts finally submitted and 18 accepted.

Mentoring

programme

In 2024, the second edition of the mentoring programme mentored 20 mentees with the support of 7 mentors. The goal of this programme is to link students and young professionals to mentors, who are themselves established public health professionals. It is an opportunity for experts to share career advice and research-related activities, and for mentees to get to know the European Public Health field and its 25 stakeholders. 163 applicants applied for the mentoring programme, out of which 140 were selected for the first edition of the mentoring programme.



European Public Health Week (EUPHW) - 6th edition

Since its inception in 2019, EUPHW has been an essential platform for raising awareness and fostering collaboration among the public health community across Europe.

For this 6th edition, the overarching theme "Health is a political choice!" was chosen as EUPHA's contribution to raising awareness on the critical intersection of politics and health, especially with the numerous elections held globally and across Europe in 2024.



Each day of the week addressed a specific public health topic, starting with daily kick-off webinars.

• Monday, May 13th: Health is a political choice: Starting the discussion

• Daily partners: WHO Regional Office for Europe, the European Commission's DG SANTE and the European Observatory on Health Systems and Policies

A high-level panel was held both online and in person in Brussels and questioned "Is public health relevant in the new world?". The panelists explored how public health can address current European and global challenges, emphasising the need for strong leadership, innovative approaches and better communication of our messages to the stakeholders and the public. A recording of the webinar is available <u>here</u>.

EUPHA also organised a Radical Community Management Training to equip public health advocates with tools to better collaborate and communicate effective public health messages.

During the 25 other events, conversations were started on how we can drive actionable steps toward a healthier future, by prioritizing health on political agendas.

- Tuesday, May 14th: Mental health: People at the centre
 - Daily partners: WHO Regional Office for Europe's Mental Health unit and Mental Health Europe (MHE)

The 28 events discussed mental health policies and politics, co-creation and innovation, among other topics. Many brave people with lived experience of mental health issues shared their stories.

Wednesday, May 15th: Planetary health: A glocal approach (global + locαl)

• Daily partner: WHO Regions for Health Network (RHN)

From insights into building age-friendly cities to discussions about global and local health policies, this theme inspired 35 events across many different countries In Europe - but not only, with one event organised in Colombia.

• Thursday, May 16th: Health through the life course: Breaking down silos

• Daily partner: UNESCO Chair Global Health and Education.

33 events were organised all around Europe on this theme and focused on the need for a lifespan approach to tackle some of the biggest health issues.

• Friday, May 17th: Next generation: Public health of today and tomorrow

EUPHAnxt and its partners coordinated an event where the young voices explored the urgency of coming together to create stronger messages if we want to drive change in the years to come. The 32 other events organised spotlighted the voices of tomorrow and harnessed their fresh perspectives to drive innovation and challenge the status quo.

This week was geared towards all 750 million Europeans. During the five days, a total of 154 events were held across 31 countries in 20 different languages. For the first time, the EUPHW hosted more in-person than online events, and more than half of all events were targeted at local communities. This enthusiasm and engagement from the public health community demonstrate our collective commitment to improving health across Europe. The European Public Health Week is not only a moment, it is a movement!



European Public Health Conference - 17th Edition

The European Public Health (EPH) Conference is a crucial event for the European Public Health Association (EUPHA). This annual scientific conference offers a platform for information exchange and debate among researchers, policymakers, and practitioners.

Each year, the conference is organised in a different country by the EPH Conference Foundation in close cooperation with EUPHA and one or more local partners. Through the Conference, EUPHA also actively seeks to develop partnerships with other European NGOs and institutions.

This year, a record number of 3.023 delegates from 83 countries attended the conference, whose program included 7 plenary sessions, 24 pre-conferences, 125 workshops, 51 oral sessions and 22 poster walks.

Given the record number of abstracts received (3364), it was offered a new format called PechaKucha (a storytelling format in which a presenter shows 20 slides for 20 seconds per slide) allowing 34 more sessions to be presented.

European Journal of Public Health

The European Journal of Public Health (EJPH) is a fully Open Access multidisciplinary journal in the field of public health, publishing contributions from social medicine, epidemiology, health services research, management, ethics and law, health economics, social sciences, and environmental health. As a science-based organisation, publishing the EJPH is a very important tool to strengthen the scientific and independent voice in the field of public health and health services.



The EJPH is published bimonthly and each issue provides a forum for discussion and debate of current international public health issues with a focus on the European region.

In the six issues of 2024, 172 original manuscripts, 11 editorials and 5 viewpoints were published. Each of the six issues also had a section with *European public health news* from EUPHA and partner organizations.

The manuscripts have been submitted from 82 countries from all continents.

In addition to the regular issues, EUPHA also supports the publication of supplements and ecollections. These two products allow deep insights in specific public health topics.

The supplement is a collection of seven to fifteen papers, including an editorial written by the guest editor, and is particularly useful to analyse a topical public health issue.

The e-collections are a selection of eight to fifteen papers recently published in the EJPH, accompanied by a newly written editorial. These editorials specifically target policymakers, summing up the evidence from the selection of papers and clarifying the link with policies.

The current impact factor of the journal is 3.7 which has dropped from 4.4 last year. The total number of manuscripts received in 2024 was 801, of which 751 were original articles. The number of monthly submissions has remarkably increased in 2024 after a dip in 2022-2023, while the acceptance rate decreased from 35% to 24% between 2023 and 2024.

Rapid Response Team

In order to be able to provide the evidence-base on a large number of public health topics in a short period of time, EUPHA created the Rapid Response Team in 2019.

This team of 25 public health experts (mostly section representatives), linked through a WhatsApp group, can be contacted by media or policymakers who quickly want an evidence-based answer on a specific topic.

The members of the Rapid Response Team were offered a media training, presented by Ricardo Mexia.

EUPHA received several requests from the press.

1. **Medscape** handled by the Infectious diseases control section regarding vaccination and measles.

2. **Economist** handled by the Sexual and gender minority health regarding the Economist Impact developing a research programme that aims to estimate the potential impact of selected interventions designed to reduce economic and/or health disparities among older adults, particularly gender-related disparities.

EUPHA is an active member of GNHiAP, promoting the Health in All Policies approach at the international level. Through this platform, EUPHA contributes to the exchange of knowledge, supports intersectoral collaboration, and advocates for policy coherence in public health worldwide.

• International presence and visibility

In 2024, EUPHA further increased its involvement in global discussions on public health governance, determinants of health, equity, and health diplomacy. These engagements reflect our commitment to ensuring Europe's voice contributes meaningfully to shaping the global public health agenda.



EUROPEAN PROJECTS

EUPHA has a long history of participating in EU-funded projects and is interested to explore options for contributing to new project proposals. EUPHA can deploy its tools and network for the benefits of EU-funded projects. In practice, EUPHA often has specific tasks in the dissemination and communication work packages.

In 2024, EUPHA continued their collaboration in different EU-funded projects.

RIVER-EU

→ Reducing Inequalities in Vaccine uptake in the European Region – Engaging Underserved communities

Duration of the project: 2021 - 2026

Using an interdisciplinary approach, RIVER-EU collects evidence on health system determinants of high and low vaccine uptake in eight specific contexts, which will be used to identify and/or develop interventions to reduce barriers to vaccine uptake in underserved communities and increase trust in the health system.

As a partner in the Work Package 7 (Dissemination and exploitation), EUPHA participates to ensure maximum RIVER-EU visibility and the sustainability of its results beyond the lifetime of the project. In 2024, EUPHA organised a consortium meeting at the EPH conference in Lisbon and supported in organising the pre-conference "From insight to impact: Advancing Equitable Vaccination Across Europe".

PROPHET

→ a PeRsOnalized Prevention roadmap for the future HEalThcare

Duration of the project: 2022 - 2026

The PROPHET Project kicked-off in 2022. It is funded from the Horizon Europe Programme. The project aims to engage organisations and individuals to contribute to the construction of a Strategic Research Innovation Agenda (SRIA) to adopt Personalised Prevention approaches into EU health systems.

EUPHA was involved in various communication and dissemination tasks within the project in the past years. 2024 marked a year of transformation within EUPHA. Hence, contribution to PROPHET was limited and will be intensified on capacity building of policy makers and Public Authorities staff in the future.

EARLY

→ Evaluating, Identifying and Reducing determinants of MHCs in Youth

Duration of the project: 2024 - 2027 The EARLY project kicked-off in 2024. It aims to reduce the burden of non-communicable diseases such as mental health conditions (MHC), especially depression, anxiety, stress disorders, substance use disorders and identify and reduce risky modifiable exposures for these conditions in youth. EARLY will pursue this goal through developing a comprehensive exposure matrix which can be adapted to emerging new risks, to understand youth, parents`, and stakeholders perceptions. Qualitative interviews will be conducted, providing representative, multinational data on youth MHC and through developing, implementing and evaluating a multicomponent intervention.

EUPHA supports within WP 10 - Dissemination and Communication via organizing policy dialogues, evidence briefings, workshops, or round table discussions, e.g., during the EPH conferences.

Projects have come to an end:

HealthData@EU Pilot - EHDS2 Pilot

→ Piloting an infrastructure for the secondary use of health data



Duration of the project: 2022 - December 2024

The HealthData@EU Pilot project was the second project joined by EUPHA in 2022. The EHDS2 pilot is funded through the EU4Health Programme. It aims to set up concrete foundations for the future so-called European Health Data Space for the secondary use of health data. In 2023, the first year of the project was completed, with several (technical) outcomes, such as a proof of concept for the IT infrastructure. EUPHA contributed, as work package leader, to the dissemination and communication activities. 2023 also marked the start of the second and final year of the pilot project. In 2024, EUPHA's role focused on specific finalisation activities, e.g., to coordinate the EHDS2-supplement to the European Journal of Public Health, which will be published in 2025.

EXACT

→ European network staff eXchange for integrAting precision health in the health Care sysTems

Duration of the project: 2019 - 2024

ExACT started early 2019. The exchange project aims to build a community of academic and nonacademic entities that generates high quality, multidisciplinary collaboration through exchanging knowledge in research and training activities on precision health. By building up on the PRECeDI Consortium it will include other relevant sectors in order to strengthen and broaden the research and training activities of the existing network and reinforce international and intersectoral cooperation. By sharing knowledge, building synergies and expertise and encouraging an exchange of best practice among top-level institutions, it will give impetus to the translational efforts necessary to implement precision health into the EU health care systems. The ExACT project has received funding from the European Union's Horizon 2020 research and innovation programme MSCA-RISE-2017 Marie Skłodowska-Curie Research and Innovation Staff Exchange (RISE).

In 2023, the exchanges via ExACT continued, and EUPHA hosted two secondees. In the final year of 2024, EUPHA had no capacity to host further secondees in Utrecht.

A strategic shift: establishing a dedicated Brussels presence

In 2024, EUPHA significantly enhanced its advocacy capacity by recruiting a Head of Advocacy and Policy, physically based in Brussels. Initially hired as a Senior Policy Officer in October 2023, Sarah Abitbol quickly assumed a strategic leadership role, strengthening EUPHA's visibility, influence, and policy engagement across EU institutions.

Starting in October 2024, in less than three months, she represented EUPHA at 34 strategic events, accounting for 40% of the organisation's total 84 representations in 2024. This figure equalled EUPHA's entire annual total for 2022 and exceeded more than half of 2023's activity, marking a substantial increase in both presence and impact.

Transforming visibility into strategic engagement

EUPHA's physical anchoring in Brussels enabled real-time engagement in the EU policy environment. Beyond attending events, the Head of Advocacy and Policy proactively took the floor, initiated conversations, and ensured EUPHA's voice was heard in key discussions on health security, public health systems, and cross-sectoral resilience and One Health.. She also covered the European Commissioner Olivér Várhelyi's hearing and the Politico Healthcare Summit live on X (formerly Twitter), signalling to Brussels-based NGOs that EUPHA is present, attentive, and actively engaging in shaping the policy discourse.

This visibility revealed and activated EUPHA's untapped potential. Rather than simply being seen as a scientific organisation, EUPHA emerged as a timely, trusted, and policy-relevant actor, shaping high-level dialogues and strategically bridging the gap between science, policy, and civil society.

Building bridges: relationships, trust, and strategic access

The Brussels presence was also leveraged to nurture and reinforce relationships with longstanding partners, including EuroHealthNet, ASPHER, the European Observatory on Health Systems and Policies, and Eurocare. At the same time, it enabled the creation of new strategic alliances, including with the European Hospital and Healthcare Federation (HOPE), one of the oldest NGOs in Brussels, and the European Brain Council (EBC), a highly influential and well-connected organisation. EUPHA also maintained active communication with the European Public Health Alliance (EPHA), ensuring continued awareness of wider NGO developments.

At a time when Brussels-based civil society was marked by fragmentation and competition, EUPHA deliberately positioned itself as a neutral, collaborative, and unifying actor. Supporting rather than competing with others, and acting as a bridge between NGOs, institutions, and science.

This trust-building approach yielded tangible results: access to informal policy intelligence, early insights into institutional developments, and inclusion in confidential conversations. It demonstrated that the true potential of Brussels advocacy can only be activated through a consistent, relational, and trusted physical presence.

Launch of EUPHA's first-ever lobbying strategy

To consolidate this progress, the Head of Advocacy and Policy designed and launched EUPHA's first-ever lobbying strategy (2025–2030). Built entirely from scratch and aligned with the 4E strategic framework, the strategy sets clear thematic priorities, engagement tactics, and institutional targets for the coming years. It also addresses structural advocacy gaps and builds a long-term foundation for EUPHA's influence in Brussels.



When the Head of Advocacy and Policy took up her role in October 2024, the new European Commission was about to be appointed, and no official working programme had yet been released. Despite this institutional uncertainty, EUPHA was the first public health NGO to identify and speak openly about the growing relevance of health security as a likely political priority. By combining this early political analysis and understanding of EU institutional dynamics with a clear operational roadmap, EUPHA is now strategically positioned to lead in upcoming EU discussions on preparedness, funding, legislation, and cross-sectoral coordination. This forward-looking approach allowed EUPHA to step into a leading role on health security well before it was formally recognised at institutional level.

Policy impact and strategic foresight

EUPHA's strengthened visibility, credibility, and network activation led to concrete advocacy results. Notably, the Head of Advocacy and Policy coordinated a joint civil society reaction in response to the Council Conclusions on Cardiovascular Health, published in January 2025. This effort unified NGOs around a shared position on a topic that, at the time, had not yet been officially prioritised at EU level.

Immediately following Commissioner Várhelyi's hearing in late 2024, EUPHA identified Cardiovascular Health as a likely key theme and acted early. This strategic foresight would be confirmed in March 2025, when the Commissioner announced that Cardiovascular Health would be one of the two major health policy initiatives for 2026. EUPHA is now well positioned to engage with the Commission on this agenda.

The joint reaction is intended to serve as a lobbying tool to influence the legislative direction of this upcoming initiative, reinforcing EUPHA's leadership and ability to anticipate and shape EU health priorities.

EUPHA also ensured representation in strategic policy dialogues with:

- DG HERA, following a bold lobbying approach that secured direct exchanges with its Director
- WHO/Europe, attending RC74 in Copenhagen
- DG SANTE, during the Annual Public Health Policy Platform in Luxembourg
- Members of the European Parliament, particularly from the SANT and ENVI Committees

Connecting members to policymakers

The new lobbying strategy also translated into direct value for EUPHA's network. The Head of Advocacy and Policy facilitated meaningful connections between EUPHA members and relevant EU-level stakeholders. Notable examples include:

- Facilitating the participation of MEPs András Kulja and Vlad Voiculescu in EUPHA's midterm conference session on health workforce resilience, held on 21 March 2025
- Connecting Dr. Elena Petelos and Viola Wohlfarth (Dachverband der Österreichischen Sozialversicherung) to EU discussions on Health Technology Assessment (HTA)
- Introducing Dr. Ricardo Mexia (President of EUPHA's Section on Infectious Disease Control) to researchers from the EU Horizon 2020-funded JITSUVAX project, facilitating collaboration on combating public health misinformation

These examples reflect how EUPHA has evolved into a connector between national expertise and EU-level policymaking, reinforcing its role in translating science into policy.



Capacity building and outreach

Reflecting the ambition of the EUPHA Strategy 2025–2030, efforts in 2024 moved beyond visibility to systemic implementation. A key example was hosting Tessel Boonstra, a Master's student from Wageningen University, whose internship focused on health lobbying within the EU. This collaboration aligns directly with EUPHA's objectives to:

- Enhance health literacy and capacity among young professionals;
- Foster a better understanding of the EU's political structure;
- Support the next generation of public health advocates.

Her research on improving transparency and strategic effectiveness in health lobbying reflects the operationalisation of EUPHA's long-term vision.

BioMed21: A Platform for Policy-Relevant Research

EUPHA also took part in the BioMed21 EU Science Policy Workshop in November 2024, focusing on human-centric research tools and unmet medical needs. This high-level meeting convened EU institutions, industry, and civil society to align strategies for innovation and public health. EUPHA will be listed as a co-author of the resulting workshop report, further reinforcing its role in evidencebased policymaking dialogues.

Policy monitoring and internal knowledge sharing

The Head of Advocacy and Policy also contributes a monthly policy update to the internal EUPHA newsletter, providing timely insights on key developments within the EU health policy landscape in Brussels. This regular input supports informed decision-making across the network and enhances EUPHA's collective situational awareness within the Brussels policy "bubble."

COMMUNICATION

Newsletter

The EUPHA newsletter aims to build the knowledge of public health professionals worldwide and to increase the visibility of EUPHA as an association that builds capacity, knowledge and policy in the field of public health, with an emphasis on the European Region. The newsletter is published monthly, free of charge and available to all those with an interest in public health.

The newsletter continues to be one of the most visible and highly appreciated tools of EUPHA.

The number of subscribers to the newsletter keeps increasing, with around 36,000 subscribers from 175 countries worldwide in December 2024.

Since 2023, we have been increasing our posting on LinkedIn as many of our stakeholders are active there. The increased posting came with an increased number of followers that has more than tripled in 2 years.





EU Elections campaign

During the 10 weeks before the European Elections, every Monday, we have been sharing the <u>10</u> <u>priorities</u> outlined by the EU4Health Civil Society Alliance, to secure health on the political agenda.

- 1. Dedicate a Vice President for health in the European Commission
- 2. Allocate a budget to health promotion and prevention
- 3. Adopt a Civil Society strategy to empower people and communities
- 4. Allocate sustainable fundings for CSOs
- 5. Address the challenges of non-communicable diseases (NCDs)
- 6. Address health inequalities
- 7. Promote holistic, person-centred and integrative health care
- 8. Establish a European Health Union
- 9. Develop actions to foster health-enabling environments
- 10. Implement the "Health in all policies approach"

Each of the ten priorities was focused on a different topic, highlighting the diverse issues to reach a healthy Europe. The objective was to make people aware of the importance of securing health on the political agenda.

OUTLOOK 2025

2025 will mark the **first year of implementing EUPHA's new 4Es strategy**, a bold and ambitious roadmap grounded in **Evidence, Equity, Empowerment, and Engagement**. We are entering this new phase with renewed energy and concrete tools to guide our progress.

Key developments in 2025 include:

- Translation of the 4Es strategy into an operational roadmap to guide action and measure success.
- Launch of a new website to improve access to knowledge and highlight the work of our sections and members.
- Implementation of a new communications strategy, developed by a working group with clear indicators to measure impact.
- Stronger connections with members and sections, supported by our expanded team.
- **Opening of European Public Health Week 2025 at the European Parliament**—a historic first for EUPHA.

EUPHA will continue to **evolve, adapt, and innovate**. Our vision remains unwavering: to build a healthier, more equitable Europe by ensuring public health knowledge is not only generated but actively applied in decision-making and community action. Though significant challenges lie ahead, the collective strength of our network prepares us to address them confidently.
